Dear Senator Lee

This is to inform you that I have considered the recommendations of your committee concerning the FY 84-85 plan for the utilization of WHEDA surplus reserves. Based on this recommendation, I am modifying the plan by transferring \$500,000 from Plan Category 1, "Lending and Liquid Reserves," to Plan Category 4, "Grants and Services." I am persuaded that WHEDA can make good use of these funds to support innovative housing efforts such as those identified in your committee report.

Because this modification is within the range recommended by the committee, I presume that this modification is agreed to by the committee. Furthermore, because s. 234.165(2)(b)4, Wisconsin Statutes, in part, provides that "if a standing committee and the Governor agree to modifications in the plan, the review period for all standing committees is continued until 10 days after receipt by the committees of the modified plan," I presume the modified plan will take effect 10 days after receipt of this letter and attachment by your committee and the Assembly committee on Governmental Operations unless one of the committees objects during this period.

I will be encouraging Mr. Jackamonis and the WHEDA board to examine proposals made to them with great care and to fund those proposals which can demonstrate strong management and which hold the most promise for providing decent affordable housing to low and middle income people.
