Department of Industry, Labor and Human Relations October 19, 1984

To the Honorable, the Senate:

In 1980 the legislature passed a law requiring that many older housing units be weatherized or meet energy efficiency standards. This was done as an energy conservation measure. Wisconsin Statute 101.122 directed the State Department of Industry, Labor and Human Relations (DILHR) to:

1. Establish a minimum energy efficiency standard of prescriptive conservation measures based upon a cost payback within five years due to energy saved.

2. Set standards for inspection and certification of rental units.

3. Adopt rules for the certification of inspectors and establish a maximum inspection fee which could be charged by independent certified inspectors.

DILHR adopted administrative rules to accomplish these responsibilities on January 1, 1983, as Chapters 67 and 68. Administrative procedures and forms have been developed and are presently available for program implementation.

Enforcement of these rules begins January 1, 1985. After that date, owners of rental property covered by the law, WHO WANT TO TRANSFER TITLE IN SALE OF THEIR PROPERTY, must have been issued a certificate of compliance by a DILHR-certified energy efficiency inspector or exercised one of their options under the waiver and stipulation provisions in the code (explained in the attachment).

The availability of inspectors will be an important factor in a smooth running program. The Training and Certification Unit of Safety and Buildings to date has certified over 700 inspectors and has scheduled enough training/exam dates to double that number before January 1, 1985. A current list of inspectors certified for rental unit inspections is included in this packet and you will be updated at the end of the year.

Because of the significance of this law and the rules to implement it, we have attached to this letter a copy of the rules, and some basic facts about the program to help you and your staff answer any questions you may get about it from your constituents. You may find this information useful if you wish to address the program in your local news column.
