## **EXECUTIVE COMMUNICATIONS**

#### **Executive Order Number 81**

I, Anthony S. Earl, Governor of the State of Wisconsin, pursuant to Section 11 of Article IV and Section 4 of Article V of the Constitution of Wisconsin, do require the convening of a special session of the Legislature at the Capitol in Madison, beginning on September 24, 1985 at 10:00 a.m. solely to consider and act upon the following specific legislative business:

- 1. Creating a nine-member strategic planning council to examine long-term economic issues and advise the governor and the legislature;
- 2. Increasing the Department of Natural Resources (DNR) permit coordination staff and creating the position of Special Assistant to the Secretary to direct that staff and requiring the DNR to designate a business liaison in each district;
- 3. Establishing procedures within the DNR for the testing, inspection and exemption from regulation of non-toxic fly ash, paper mill sludge and foundry sand;
- 4. Permitting recovery in certain cases of legal costs by a small business which prevails in an administrative contested case or in a legal action by a state agency;
- 5. Establishing procedures and regulations limiting the diversion of water from Wisconsin;
- 6. Requiring the State Investment Board to establish, by rule, annual goals for investments in small Wisconsin firms;
- 7. Increasing the state contribution to Forward Wisconsin;
- 8. Increasing the funding for the Technology Development Fund;
- 9. Providing one-time, start-up funding for the Wisconsin Cooperative Development Council, Inc.;
- 10. Appropriating state dues for the Midwest Technology Development Institute;
- 11. Adding staff to the state's German trade office;
- 12. Creating an International Agri-business Marketing Center in the Department of Agriculture, Trade and Consumer Protection;
- 13. Making people recently hired or transferred by a Wisconsin firm who are working full-time immediately eligible for in-state tuition at the University of Wisconsin;
- 14. Requiring the University of Wisconsin to start classes after the first day of September;

- 15. Providing for demonstration grants by the Department of Public Instruction for education and employment pilot projects;
- 16. Requiring the Department of Revenue to make certain adjustments in its valuation of agricultural land;
- 17. Permitting utilities to diversify for certain purposes, limited to a fixed percentage of the utility's equity.
