Dear Speaker Loftus:

As properly shown by the report of the Committee on Assembly Organization, Assembly Bills 13, 14, 15, 16, 17, 18 and 19, May 1986 Special Session, were introduced by that committee "at the request of". Bills 13 to 16 were "requested" by Rep. Becker and others; bills 17 to 19 by Rep. Black.

Unfortunately, at the time of introduction nobody had told the word processing operators on the Chief Clerk's staff that the bills were introduced by Assembly Organization "at the request of ...". The computer's bill history records were established to read "Introduced by Representatives Becker ...." and "Introduced by Representative Black". The histories still had that wording at 4 p.m. on Wednesday (see copies enclosed).

Since the bill introduction information is placed on the camera-ready copy by computer (from the computer-stored bill histories), the printed copies of AB 13 to 19, My6SS, also fail to mention that the bills were officially introduced by the Committee on Assembly Organization.

Because the committee record clearly indicates that the bills were properly introduced under Assembly Rule 93 (2), the bills have been validly introduced regardless of what it says on the printed copies. I recommend that we save the Wisconsin taxpayers some money and do not reprint the 7 bills for the sole purpose of adding the words "Introduced by Committee on Assembly Organization, by request of" to the introductory information shown on each bill.
