To the Honorable, the Senate:

Enclosed is a copy of the Minority Alcohol and Other Drug Abuse Needs Study, dated December 31, 1984. This report was prepared by the State Council on Alcohol and Other Drug Abuse, utilizing staff within the Wisconsin Department of Health and Social Services and members of the Citizens Council on Alcohol and Other Drug Abuse, Committee on Minorities and Poor.

The State Council has, over the past several months, conducted a comprehensive study of minority AODA needs utilizing public hearings and other objective information. We have carefully considered both objective and subjective information, made findings, and formulated recommendations. We believe that implementation of these recommendations would be a significant step toward addressing the alcohol and other drug abuse problems of minorities in our state.

The State Council considers the needs of minorities to be extremely important and in need of your immediate response. We ask that you favorably consider our report and that you act upon our recommendations during the forthcoming state budget and legislative process.

To the Honorable, the Senate:

Enclosed is the result of an abandoned waste site inventory you directed the DNR to complete. The report lists every known location in Wisconsin where wastes were buried. Almost every incorporated area and certainly every legislative district is "home" to buried wastes.

The report is also a tool for planning which waste sites warrant state or federal cleanup. To understand the gist of this material, I suggest reviewing the attached news release and the executive summary on pages iv-vi.

To find out which waste sites were identified in your constituent areas, turn to appendices B and C. Appendix B (pages B1-B57) lists all known abandoned dump sites. Appendix C (pages C1-C32) lists all currently active or working landfill sites. In both appendices, waste sites are listed alphabetically by county with DNR districts.

To use this information, first, turn to page ii to see which counties are located in which DNR district. Then turn to the appendices. Sites are listed alphabetically starting with the Lake Michigan District, then the North Central District, the Northwest District, the Southeast

District, the Southern District and finally, the West Central District.

For example, to locate sites in Milwaukee, find the Southeast District listings in appendices B and C, then look for Milwaukee County listings.

Managing Wisconsin's wastes -- abandoned or new -- will continue to be an important environmental legislative issue. I trust you will find this document a valuable resource for further discussions.

**Senate Resolution 2**

In **Senate Resolution 2**, Senate Rule 8(3) is split into 2 simple declaratory sentences "No member may....".

When the rule was a single sentence, the condition "while the ayes and noes are being called" applied to both parts of the rule (nothing in the drafting record indicates an intent to change that).

The intended phrasing for the first sentence was: "No member or other person may visit or remain by the clerk's table while the ayes and noes are being called."

In engraving, the condition was reinserted into the first sentence as shown by the underscored text.
