To the Honorable, the Senate:

The attached report, "Department of Health and Social Services Library System Plan," was prepared pursuant to Chapter 347, Wisconsin Laws of 1979, which directed the Department to submit a plan for the provision of library services at its institutions to the Legislature. The Library System Plan was prepared under a federal Library Services and Construction Act (LSCA) grant and the project director who developed the report was funded through that grant.

The recommendations included in the report are the result of extensive scrutiny of the individual institutional libraries. I believe that considerable knowledge has been gained about current library operations due to the involvement of professional library staff. The plan provides the parameters for a more efficient and effective utilization of our institutional library resources.

However, it is important to note that many of the recommendations in the Plan require additional resources. The 1985-87 budget of the Department does not include requests for these additional resources. This submittal of the Plan does not constitute such a request. Consequently, priorities among the recommendations must be established based on those which can be initiated and implemented from existing resources or library funding.

We have submitted to DPI/Division for Library Services three inter-related library funding grant requests. The first grant relates to the Coordinator position and totals \$41,621. The second represents a combined DCTF/DOC grant request of \$38,000 to continue and expand the existing library-based Literacy Project. The third grant request asks for \$12,271 to facilitate the retrospective conversion into machine readable form of over 90,000 existing library records for integration into the state-wide database, WISCAT. In total, we are requesting DPI to support the attached Library System plan with \$91,892 in federal LSCA funds.

I should also note that the Library Services Coordinator position would be a joint appointment in the Divisions of Corrections and Care and Treatment Facilities, in keeping with the procedures followed since the beginning of the 1983-84 library study project.

I have several other comments regarding the Plan that deserve mention in this transmittal letter:

First, the recommendation that separate budgets for libraries and library services be established along with a library budget allocation formula is not likely to be implemented. Although I understand the perspective of the author of the Plan, I do not believe that the Department should separate library services from institution budgets any more than data processing services should be so separated. Nor do I feel that an automatic formula allocation of resources is feasible or appropriate in the budget preparation and decision making process.

Second, the recommendation regarding the responsibility of the Department's library system to work to increase funding for public library systems should not be interpreted to be an authorization item for independent lobbying. The intent and meaning is its responsibility for advocacy within the institution, the Department and the executive branch for the resources necessary to improve institutional library services.

Finally, the report, due to its specific purpose, places its emphasis on the structural development and organization of a departmental library system. It must be remembered that an improved system is merely a means to providing improved services to DHSS clients.
