STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin on June 3, 1985 upon the following claims:

THE BOARD FINDS:

- 1. Karen Apel of Milwaukee claims \$768.25 for medical expenses incurred in August and September 1984, as a result of a misunderstanding regarding her insurance coverage during the summer months between semesters as a teaching assistant at the University of Wisconsin-Milwaukee during the 1983-84 and 1984-85 academic years. The Board concludes the claim should be paid in the reduced amount of \$573.53, which reflects the amount of medicals less the \$48.68 premium claimant would have paid each month during the summer, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the University of Wisconsin appropriation s. 20.285(1)(a), Stats.
- 2. Frank Sever of Tower, Minnesota, claims \$3,000,000.00 for damages relating to the alleged wrongful detention of his uncle, Tony Sever, in state institutions from 1932 to 1966. Tony Sever was committed to the Mendota State Hospital by order of the Douglas county Court dated February 13, 1932, as the result of examinations by two physicians appointed by the court. In February, 1935, he was transferred to the St. Croix County Hospital where he remained until his death in June 1966. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the

state should assume and pay based on equitable principles.

- 3. Grant Verhulst of Osseo claims \$19,296.00 for expenses and damages relating to the failure of a business he became involved in through the assistance of the Division of Vocational Rehabilitation (DVR), Business Enterprise Program in 1982. Claimant is legally blind. Pursuant to s. 47.03(4)(a), Stats., the Business Enterprise Program is established to provide consultative services to or operate businesses for the benefit of blind persons. with the ultimate objective of enabling blind persons to operate their own businesses. Claimant leased a mobile concession facility owned by DVR. Claimant alleges the state was negligent in conducting its portion of the program resulting in the termination of his "corn roasting" business. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 4. Ruth Gerhardt of Sun Prairie claims \$99.95 for loss of a woodworking tool on January 31, 1984, allegedly stolen from a classroom at the Sherman School where she is employed as a teacher. The Department of Health and Social Services advises that additional security measures have been added to the classroom since this incident occurred. The Board concludes the claim should be paid in the reduced amount of \$75.00, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.430(2)(gk), Stats.
- 5. Ronald Nelson of Marinette claims \$10.81 for reimbursement of a prescription he purchased at a pharmacy in Menominee, Michigan on March 25, 1983. Effective October 1, 1982, claimant became a recipient of the Wisconsin Medical Assistance Program. Pursuant to ss. HSS 105.48, 107.02(3)(c), 107.03(8) and 107.04, Wis. Adm. Code, the Medical Assistance Program may pay benefits provided by out-of-state providers if the provider or recipient has applied for and been granted 'prior approval" of the requested benefit before the benefit was actually provided to the recipient. Claimant was advised by the pharmacy in Michigan that they do not accept Wisconsin Medical Assistance. The Board concludes there has been no showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 6. John Harings of Chippewa Falls claims \$27.99 for replacement cost of his automobile tail light which was damaged by a resident of the Northern Wisconsin Center on December 17, 1984, while the automobile was parked in the lot at the Center. An employe of the Center observed the resident causing the damage to the

- claimant's car. The Board concludes the claim should be paid based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(2)(gk), Stats.
- 7. Audrey Tiegs of Summit Lake claims \$50.00 for loss of a copper boiler which was disposed of in the Fall of 1984, when she requested the Department of Natural Resources to pick up some arsenic and pesticide wastes which she possessed. The Department of Natural Resources paid for the pick-up and disposal of the wastes through a private contractor. Claimant used the boiler as a container for the wastes and the private contractor picked up and disposed of the boiler along with the wastes. The Board concludes the claim should be paid based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Natural Resources appropriation s. 20.370(2)(du), Stats.
- 8. Donald Scheele of Milwaukee claims \$31.50 for replacement cost of an automobile window allegedly broken by unknown persons during an attempt to burglarize his automobile on December 11, 1984, while it was parked in the guarded and patrolled parking lot at the Department of Natural Resources Southeast District Office in Milwaukee. The Board concludes the claim should be paid based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Natural Resources appropriation s. 20.370(2)(ma), Stats. The Board suggests that future claims of this nature be avoided by the installation of signs disclaiming responsibility for similar damage that may occur in the future.
- 9. MSI Insurance of St. Paul, Minnesota, claims \$927.66 for subrogation damages and the deductible amount paid by its insureds, Terry and Linda White, for damages to their boat allegedly caused by a Department of Natural Resources Conservation Officer on July 14, 1984, at Kinnickinnic State Park. The damage was allegedly caused when the conservation officer boarded and searched the boat. The Board finds there has been no showing of negligence on the part of the state, its officers, agents or employes and consistent with the long-standing policy of this Board concerning subrogation claims the Board concludes the claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
