To the Honorable, the Senate:

The 1983 Wisconsin Act 203 authorizes cities and counties to be designated as agents of the Department of Agriculture, Trade and Consumer Protection for inspecting and issuing permits and licenses for counter freezers, bakeries, confectioneries, and retail food processing plants. A nonstatutory provision in this new law directed the department to develop by July 1, 1985, a program budget which identifies the costs and revenues associated with regulating, issuing licenses to, investigating and inspecting these establishments under Chapter 97 of the statutes.

Pursuant to this directive and as provided for in section 13.172(2), a copy of the report that was developed and prepared by the department is submitted to your office for distribution to the appropriate legislative office.
