Council on Alcohol and Other Drug Abuse
To the Honorable, the Senate:

This report is in response to Wisconsin Statute 14.24 which mandates that the State Council on Alcohol and Other Drug Abuse shall (a) consider all questions and matters relating to abuse prevention. (b) Coordinate and review efforts by state agencies to prevent and control alcohol and other drug abuse and make recommendations to such agencies. (c) In each report under s. 15.09(7), review control and make recommendations for further legislation.

15.09(7) Annual Reports. In August of each year, every council created in a department or independent agency shall submit, to the head of the department or independent agency, a report on the operation of the council during the fiscal year concluding the preceeding June 30.

During fiscal year 1985, the State Council on Alcohol and Other Drug Abuse met in August 1984, December 1984, February 1985, April 1985 and June 1985. Copies of the agendas and proceedings are attached.

Interdepartmental Coordination and Information Sharing

During fiscal year 1985, increased emphasis was placed on departmental and representative members' reports to facilitate information sharing and interdepartmental coordination. A new format was implemented enabling specific representatives to present an in-depth twenty-minute report to identify policy, legislative, funding and program issues for the Council's consideration. In addition, the Council heard a representative from the "I'm Driving Club" president, and endorsed the concept as a viable prevention effort.

The State co-sponsored and sent official representatives to the 1st Annual Wisconsin Citizens Conference on AODA in October, 1984, and the National Cocaine Conference held in Milwaukee in April, 1985.
