To the Honorable, the Senate:

Enclosed please find a copy of the Administrative Rules Advisory Committee (ARAC) Report which I received on August 1, 1985. Pursuant to Section 3049 of 1985 Wisconsin Act 29, I was directed to submit the Committee's recommendations to you along with my comments regarding each recommendation.

ARAC recommended the adoption of two Administrative Rules. One Rule was directed at providing a registration exemption for common stock offerings which were made through a firm-commitment underwriting by a qualified underwriter. That rule was designed in part, according to ARAC, to offset the perception that Wisconsin is anti-business. The other Rule was designed to aid Wisconsin corporations. That Rule proposed an exemption for common stock offerings by Wisconsin companies having their principal office and the majority of the full-time employees in Wisconsin. That proposed rule set forth a number of specific conditions, including the condition that 80% of the net proceeds from the sale of securities using that exemption must be used in connection with operations in Wisconsin.

In commenting on these Rules I can state that in general I agree with the direction and approach that the ARAC took in balancing the interest of business with that of investor protection. I wholeheartedly agree with the Committee's specific recommendation that these proposed changes be brought about through administrative rules as opposed to legislation.

My specific recommendations regarding the proposed rules can be found in the enclosed copy of the Draft of Proposed Amendments to the Rules of the Commissioner of Securities. Specifically I refer you to Section 5 of that draft which creates SEC 2.025 Non-Seasoned Issuer Registration Exemption by Filing and Section 6 which creates SEC 2.027, Wisconsin Issuer Registration Exemption by Filing. Those two rules had their beginning with the two rules proposed by ARAC. The analysis section which follows each of those rules contains my specific comments regarding the ARAC proposed rules along with my comments regarding any changes or additions which my agency made to the ARAC rules in proposing them for adoption.

A copy of the "Draft of Proposed Amendments to the Rules of the Commissioner of Securities" was delivered to the Legislative Council on Wednesday, September 4, 1985.
