## Senate Resolution 9

Denouncing the anti-Semitic statements of Louis Farrakhan.

Whereas, racism in any form is dehumanizing and destructive; and

Whereas, recent statements by Louis Farrakhan have been virulently racist, filled with inflammatory and irrational anti-Semitic rhetoric; and

Whereas, the rights of the First Amendment to the United States Constitution, which may be used by those who would abridge the right to free speech, include the right, indeed the obligation, to forcefully answer the kind of unfortunate message of Louis Farrakhan; and

Whereas, Louis Farrakhan's anti-Semitism constitutes a special danger because it is cleverly woven with certain other themes that by themselves have a positive appeal; and

Whereas, the danger that officially denouncing Farrakhan's anti-Semitism gives him additional publicity is outweighed by the need to openly demonstrate that such a message is not tolerated or accepted in the United States of America; now, therefore, be it

Resolved by the senate, That the Wisconsin senate officially denounces the anti-Semitic statements of Louis Farrakhan; and, be it further

Resolved, That the senate chief clerk shall transmit copies of this resolution to every television and radio station and newspaper of record in the State of Wisconsin; and, be it further

Resolved, That this resolution be published in the journal of the senate of Wisconsin.
