Senate Rules 34 and 45 require the reading at length if resolutions are considered privileged under Rule 69 and taken up immediately. The chair has ruled in the past that privileged resolutions may be referred to committee. However, in this situation the chair not only referred the resolution to committee, but is of the opinion that the resolution is not privileged, and does not need to be read at length.

Therefore, the point of order raised by the Senator of the 20th, Senator Stitt, is not well taken.
