REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Appendix to Senate Bill 222

Public Policy Involved

The Retirement Research Committee (RRC) has studied the WRS voluntary contribution program and has recommended its phase-out and replacement with other types of deferred compensation plans. A number of concerns have been raised relative to the present program including the following:

1. The WRS voluntary contribution plan allows payment of accumulations only upon termination of employment. There are no withdrawal or rollover rights during employment.

Interest earnings are credited to voluntary accounts at the end of each year but on beginning year balances. These procedures are often misunderstood or

deemed to be inappropriate.

3. Voluntary contributions when paid in a lump sum form are determined upon book value rather than market value of WRS assets. This process can lead to negative selection against the system.

4. There are no separate administrative charges for the voluntary contribution program and hence, this program is subsidized by the retirement system and its

participants.

5. The Federal Internal Revenue service has ruled that contributions to a public retirement system under 403 (b) provisions are now restricted to those educational units that had already established a 403 (b) program through that retirement system. Hence, Federal law and rules are now phasing out this program.

6. The existing voluntary contribution program has essentially been replaced with other types of deferred compensation plans such as 401 (k) and 457 plans.

7. Participation under the voluntary contribution plan has always been small (less than 3% of all participants) and is actually declining as a percentage each year.

Based upon the above concerns, the RRC has recommended the phase-out of the authority to make voluntary contributions pursuant to 40.05 (1)(a)5. This recommendation recognizes that more appropriate

deferred compensation plans are now available to public employees.
