To the Honorable, the Senate:

Pursuant to Section 234.65 (5) of the Wisconsin Statutes, the Department of Development is directed to submit to the appropriate standing committee on each house of the Legislature, as determined by the presiding officer, a report on the lending activities of the Wisconsin Housing and Economic Development Authority. Enclosed is the Department's 1985 report which, by copy of this letter, is being transmitted to all member of the legislature. This report describes only those activities completed prior to July 1, 1985, involving the Authority's Small Enterprise Economic Development (SEED) program.

Because the SEED program had just been initiated, only nine loans were closed prior to July 1, 1985. Thus, it is not possible to describe significant lending patterns in the 1985 annual report. However, as WHEDA has now issued more than 40 SEED loans, the Department of Development will undertake a more thorough analysis in its 1986 report, which will be issued shortly.
