To the Honorable, the Senate:

1983 Wisconsin Act 27, created s. 46.275(2)(e), 46.275(5m) and 46.227(5m) of the statutes which require the Department of Health and Social Services to submit a series of annual reports on its federal Medicaid home and community-based waiver projects -- the Community Integration Projects (CIP) I and II. CIP is designed to relocate residents of the state centers for the developmentally disabled into the community. CIP II is designed to relocate or divert elderly, physically disabled and developmentally disabled persons from nursing homes into the community. CIP I was initiated October 1, 1983 and CIP II was approved by the Health Care Financing Administration on December 5, 1985, with a retroactive effective date of January 1, 1985. The required reports include: (1) an annual progress report on the CIP I, (2) an annual report on the impact of CIP I on state employees (including number of lay-offs and efforts to redeploy and (3) an annual report on the cost and quality of care for recipients participating in CIP II.

Although the latter two reports were due March 1, our office has encountered some delays in completing individual reports. Since it seemed most expedient to submit the reports as a package, we had wanted to delay the submission until all reports were complete. The primary delay was, and continues to be the annual progress report on CIP II for the preceding calendar year. We did not receive federal approval for CIP II until December 1985 and that approval was retroactive to January 1, 1985, thus creating a sizeable amount of after-the-fact developmental work. As a result, we still lack the necessary data to complete an annual report on the first 12 months implementation of CIP II. However, we do not want to continue to delay submission of the other two reports, which are finished.

Attached please find report of the impact of CIP I on state employees, as required by s. 46.275(5m) and the annual progress report on CIP I as required by s.46.275(2)(e) of the statutes.

We will submit the annual report on expenditures and quality of care for CIP II. as required by s. 46.277(5m), as soon as data becomes available. The Department has

only recently completed its review and approval process for CIP II applications submitted by counties for MA recipients served in CY 1985. As yet, we have not received any statement of expenses from the counties for these approved recipients. Such information should be available within the next two months.

To the Honorable, the Senate:

For the past several months the Department of Health and Social Services has been engaged in its annual planning process on six major block grants for the 1987 federal fiscal year. These block grants are Social Services; Community Services; Alcohol, Drug Abuse and Mental Health; Low Income Energy Assistance; Maternal and Child Health; and Preventive Health and Health Services.

As integral part of this process as specified in federal law is the requirement that the state Legislature conduct a public hearing or hearings on the Department's block grant proposals. In order to qualify for federal funds, the Department must verify that the Legislature has held the required public hearing. This will be the fifth year we have conducted this process since the federal law was passed in 1981.

At this time we are requesting that the Legislature again designate the appropriate committee or committees to conduct the required hearing. Following past schedules, the timetable for the remainder of the process is as follows:

Department submits draft proposals to the Governor and Legislature, June 6, 1986

Legislature holds public hearing(s). Recommendations submitted to the Department, by July 11, 1986.

Final applications to the Governor for review and approval, August 1, 1986.

Submittal of applications to the federal agencies, August 15, 1986.

Funding released for the 1987 federal fiscal year, October 1, 1986.

It would be highly desirable that by May 30 we confirm the date(s) you would like to hold the hearing(s) so that we can include that information into the 800 block grant proposals and summaries we will distribute to interested agencies and persons during early June. This will eliminate separate mailing of hearing notices and concurrently permits ample time for local groups to review the proposals.

Department staff will contact you within a week to follow up on the hearing date and related arrangements.
