Earlier today, the Senate's Urban Affairs, Utilities and Elections Committee voted to amend its previous modifications to "Dividends for Wisconsin", the Wisconsin Housing and Economic Development Authority Fiscal Year 1985-86 Plan for the Utilization of WHEDA Surplus Reserves, to read as follows:

The committee recommends modifying "Dividends for Wisconsin" by decreasing the allocation to "Other Housing Loans" under Plan Category 2 by \$1,350,000 and increasing the allocations to "Special Housing Situations" and "CHAP Bridge Loans" under Plan 3 and to "Housing Grants" under Plan Category 4 by \$450,00 each. Further, the committee recommends that WHEDA expend the total amount allocated under Plan Category 4 to "Housing Grants" such that no portion of the allocation may lapse to future surplus reserves.

County of burglary (PTAC) on 6/24/82 and sentenced to one year probation was granted a pardon, because she has been a productive member of society, is currently employed, has no other criminal record and sufficient time has passed since her conviction.

Douglas Balko, convicted in Rusk County of delivery of marijuana on 11/5/75 and sentenced to 2 years probation, 60 days jail was granted a pardon, because he is currently employed, wishes to be able to possess a firearm for hunting purposes, has no other criminal record and sufficient time has passed since his conviction.

Ross F. Balsom, convicted in Ozaukee County of enticing a child for immoral purposes on 9/24/62 and sentenced to two years probation was granted a pardon, because he has been a productive member of society, is self-employed, has no other criminal record and sufficient time has passed since his conviction.

John Husman, convicted in Winnebago County of burglary on 7/11/75 and sentenced to 3 years probation, 60 days in jail with work release privileges and in Winnebago County of carrying a concealed weapon on 4/9/76 and sentenced to 20 days in jail under Huber Law was granted a pardon, because he wishes to be bonded and become a licensed insurance agent, he has been a productive member of society, is currently employed, has no other criminal record and sufficient time has passed since his conviction.
