GOVERNOR'S VETO MESSAGE

August 11, 1987

To the Honorable Members of the Assembly:

I have approved Assembly Bill 483 as 1987 Wisconsin Act 38 and deposited it in the office of the Secretary of State. I have exercised the partial veto power in one instance to better reflect the intent of the legislation.

Section 49. The word "total," stricken through this veto, would have erroneously limited the ability of the Department of Industry, Labor and Human Relations to collect benefits illegally concealed by recipients to those who received benefits for total unemployment. My veto will allow collection of improperly received benefits for both partial and total unemployment.

GOVERNOR'S VETO MESSAGE

August 25, 1987

To the Honorable Members of the Assembly:

I am vetoing Assembly Bill 454 which modifies the executive service retirement plan under the Wisconsin Retirement System (WRS). This bill eliminates the plan's age 62 restriction on accrual of creditable service and earnings, but maintains the 2.0 formula multiplier and the normal retirement age of 62 for executive plan participants.

This bill represents a retirement benefit improvement for a limited number of WRS participants. Such a change is more appropriate as part of a comprehensive WRS bill which considers all retirement issues, including funding of benefits. Ample time remains to address the conflict between the executive plan's age-based restrictions and recent amendments to federal age discrimination laws, which take effect in 1988. I intend to address the age 62 limitation in a manner which recognizes the importance of retaining experienced executives in state government service and which is fair to the individuals involved.
