GOVERNOR'S VETO MESSAGE

October 15, 1987

To the Honorable Members of the Assembly:

I am vetoing **Assembly Bill 355** in its entirety. This bill raises the state minimum wage beyond the federally mandated level and is contrary to the business development efforts initiated by my administration.

AB 355 increases the state minimum wage from \$3.25 per hour to \$3.55 per hour on January 1, 1988, and to \$3.85 per hour on January 1, 1989. I believe these increases would be detrimental to both state businesses and individuals seeking employment. The state minimum wage primarily affects small businesses which create the majority of the state's new jobs. Higher minimum wage requirements would discourage small companies from adding new employees and reduce job opportunities for both young, new workers and older individuals.

I believe we need to encourage new job development in Wisconsin rather than discourage it. All of our citizens will benefit from expanding the number of available jobs. A higher minimum wage would be a step in the wrong direction. I am, therefore, vetoing AB 355.
