Dear Mr. Melvin:

This is in response to Section 3044(2h) of 1987 Wisconsin Act 399 which requires that by January 1, 1989 the state superintendent of public instruction shall submit a report to the chief clerk of each house of the legislature for distribution to the appropriate standing committees. The report shall make recommendations on borrowing agreements between between library systems, including recommendations on reimbursement provisions when justified by usage.

The issue of borrowing between public library systems has been addressed by my Task Force on Public Library

Legislation and Funding and in my 1989-91 biennial budget request. (A copy of the Task Force Report and the budget request are attached.) While these documents do include my recommendations on inter-system borrowing agreements, I will be submitting a final report which will reconcile these documents around 1988 estimated transaction figures for statewide nonresident circulation. This report will be completed no later than February 1, 1989.
