Dear Messrs. Melvin and Schneider:

Enclosed is the study and recommendations regarding the feasibility of requiring insurers to offer motor vehicle insurance policies that require all passengers in the insured motor vehicle to wear safety belts as a condition of coverage under the policy and the feasibility of requiring insurers to offer a discount in the premiums charged under motor vehicle insurance policies for safety belt users required by Section 9r, a nonstatutory provision of 1987 Wisconsin Act 132. This Office is to submit the study and recommendations to the Chief Clerk of each House of the legislature by January 1, 1989, for distribution to the appropriate standing committees.
