I write to request your permission to establish a subcommittee of the committee on Urban and Local Affairs. The subcommittee titled State-Local Partnership, will delve into several general areas mainly relating to the cooperation between the State and local governments in providing services to the citizens of Wisconsin.

Representative Leo Hamilton would chair the subcommittee and consist of the following five members of the committee on Urban and Local Affairs: Representatives Wineke, Van Dreel, Goetsch and Deininger. Some of the specific areas to be reviewed will be:
