Section 89 of the Wisconsin Act 413 of 1987 directs the Department of Health and Social Services, upon consultation with the Council on Pilot Projects for the Uninsured, to submit a progress report on the State Health Insurance Program pilots for distribution to the appropriate standing committees of each house of the Legislature.

The attached report describes the progress the Department has made in planning and implementing the State Health Insurance Program pilot projects. It briefly summarizes previous and current legislation, lists the Department's responsibilities for reporting, enumerates pilot implementation activities, and provides an update on the emergency and permanent rule processes.

There are three pilots to be implemented under the legislation. The "Non-Insuring Firm" pilot started in Outagamie County in February, 1989. Pilot enrollment efforts, local office and Advisory Committee actions are detailed.

The report also describes the "Insuring Firm" pilot, scheduled for start-up in October, 1989

On January 1, 1990 the Department will submit a second pogress report, describing the status of each pilot project, the number of persons enrolled and the amount of funds expended for subsidies and administration.

In accordance with s. 619.15(2), Wis. Stat., I am pleased to submit to you the annual report for calendar year 1988 for the Health Insurance Risk Sharing Plan. This report is for distribution to the Standing Committees on Insurance. The Plan was established in 1981, and, as of December 31, 1988, insured 3,350 Wisconsin residents.

Major activities during 1988 included:

- Issuing 2,208 new policies. This was a 104% increase over 1987.
- Assessing insurers. Insurers were assessed \$1.9 million in 1988 to make up for the difference between the expenses of the Plan and premiums collected. From 1981 to 1988 insurers have been assessed \$9 million.
- 3. Conducting a survey of policyholders. It shows that 54% of respondents are female. Sixty percent are married. Twenty-eight percent have incomes below \$12,000 a year and 53% reported that they are unemployed.
- Implementing a cost containment program. Act 27, 1987 required the Insurance Commissioner to implement cost containment provisions. Those provisions are now in effect.
- Implemented the deductible subsidy. The deductible subsidy took effect on January 1, 1988.
 As of December 31, 1988, 871 enrollees were receiving the premium and deductible subsidy.

6. Maintaining premium rates at their 1985 level.

This has contributed greatly to increased enrollment by attracting enrollees who otherwise may have sought insurance in the private market.

We have attached excerpts from the Plan Administrator's annual report to the Board of Governors. I hope this provides you with information that will assist you in making informed decisions on health insurance issues.

The Department of Health and Social Services did not recover any costs during the fiscal year ending June 30, 1989.
