Assembly Bill 6, October 1989 Special Session

Relating to providing core group training on alcohol and other drug abuse prevention to tribal and minority communities; medical assistance payment for inpatient psychiatric care; supplemental funding for alcohol and other drug abuse treatment; treatment for cocaine families; a study of the enrollment of certain recipients of medical assistance in health maintenance organizations; imposing a tax on dealers of controlled substances; providing penalties; and making an appropriation.

Assembly Bill 7, October 1989 Special Session

Relating to use of resources of parents who abuse controlled substances to meet the needs of children, use of public assistance benefits to obtain controlled substances, organized crime, certification of laboratories for performance of certain chemical analyses, suspension or revocation of operating privilege for alcohol and drugrelated offenses, granting rule-making authority, providing penalties and making appropriations.
