Pursuant to 1987 Wisconsin Act 27, Section 3024 (10r), the Department of Health and Social Services convened a Prison Overcrowding Task Force to study problems associated with the adult and juvenile justice systems. The Task Force included 22 members and began its work by first focusing upon the adult system which was experiencing the most growth and crowding. On behalf of the Task Force, the Department of Health and Social Services provided the Legislature with the requested report regarding adults in July 1989.

After concluding its work regarding adults, the Task Force turned its attention to the juvenile system. It met three times during the later half of 1989 and concluded by providing the Department with its recommendations which I am forwarding to the Legislature at this time.

In addition to the Task Force's Report, I am providing you with the response of the Department of Health and Social Services to the Task Force's recommendations. The Department's Response addresses both institutional and community juvenile justice issues.
