Enclosed is an Order of the Department of Revenue Adopting An Emergency Rule relating to the administration of the tax rate disparity payments. A copy of this emergency rule is being sent to you pursuant to the requirements specified in s. 227.24(3), Stats. A certified copy of the order has been filed in the Office of the Secretary of State and the Office of the Revisor of Statutes as required by s. 227.20, Stats.

This emergency rule will become effective immediately upon publication in the official state newspaper. It will remain in effect for 150 days after publication, when a permanent rule should be in place.

Copies of this letter and the emergency rule order are also hereby being transmitted to the Chief Clerk of the Senate and of the Assembly with the request that the
