Enclosed you will find a copy of the report entitled "Evaluation of the Day Care Kindergarten Project and the State-Funded All-Day Kindergarten and First Grade Programs", for the Milwaukee Public Schools. This report summarizes the projects and the research findings for the 1989-90 school year and is due by January 1, 1991.

It should be noted that this report was prepared in response to Sections 119.71, 119.72, 119.73 and 119.75 of the current state statutes dated February 28, 1990. It has been mandated that the board shall evaluate the effectiveness of the expanded 5-year-old kindergarten programs and the early childhood education programs in meeting the needs of disadvantaged children and provide expanded opportunities for first grade pupils who have participated in an expanded 5-year old kindergarten program.
