To the Honorable the Legislature

We have completed a management audit of the University of Wisconsin's Division of Intercollegiate Athletics. The Division has encountered serious financial difficulties recently and, unless action is taken soon, the Division's financial condition will continue to deteriorate.

We estimate the Division's funding needs for its accumulated deficit, deferred maintenance and a reasonable operating reserve will total \$5.9 million by the end of fiscal year (FY) 1989-90. This need could grow to

\$9.5 million by FY 1993-94, unless steps are taken to substantially increase revenues or decrease expenditures.

While some of the Division's financial problems are the result of unexpected circumstances, including a dramatic drop in attendance at home football games, various management decisions have contributed to the Division's financial difficulties. These decisions include inadequate financial planning for the McClain Indoor Practice Facility, continuing growth in administrative and support expenditures, and increasing expenditures for non-income producing varsity sports.

To overcome the Division's financial problems, the Legislature and the University will need to decide whether the current scope and quality of the program and the facilities needed to support it are to be maintained or whether some reductions are necessary. If the program is to be maintained at its current level, substantial increases in revenues will be required.

Improvements are also needed in the Division's financial management and in the amount of oversight provided by the Chancellor and the Athletic Board to avoid further problems and develop a long-term strategy for solving the Division's financial problems.

We appreciate the courtesy and cooperation extended to us by staff from the Division and by other University staff both in Madison and throughout the University System. The University's response is Appendix III.
