State of Wisconsin Legislative Audit Bureau

To the Honorable the Legislature:

We have completed a management audit of the Office of the Commissioner of Insurance to review the Office's progress in improving its market regulation activities since our last audit and to further evaluate the Office's complaint handling process, as requested by the Joint Audit Committee.

While the Office has made progress in improving its market regulation activities, it still needs to increase oversight to ensure quality and consistency in its market regulation activities. We found that consumer complaints were not always processed consistently among staff and that documentation did not always clearly indicate the amount of follow-up performed on the complaints and the justification for decisions reached by staff. To increase consumer awareness of the Office's complaint process, the Legislature could expand current statutory insurance contract provisions to require insurance companies to include such information on insurance contracts, renewal notices, and cancellation notices.

We also reviewed proposals presented by consumer interest groups to redefine the office's regulatory role and responsibilities by placing more emphasis on being responsive to individual consumers. The proposals call for increased responsibility to mediate complaints and provide relief for individual consumers. In addition, consumer groups believe that mechanisms independent of the Office are needed to ensure adequate representation of consumer interests.

While these proposals may help to achieve the goals of the consumer groups to place more emphasis on individual consumers, their potential effects on other aspects of insurance regulation also need to be considered. Before deciding whether the Office's regulatory role and responsibilities should be changed, it may be useful to wait until the Office can assess and report on the results of recent initiatives it has taken to improve protection and education of consumers and the effects of the proposed changes in responsibilities on its workload and staff resources.

We appreciate the courtesy and cooperation extended to us by the Office of the Commissioner of Insurance. The Office's response to the report is the Appendix.

To the Honorable the Legislature:

We have completed an audit of the Office of the Commissioner of Banking to satisfy our responsibilities under s. 13.94, Wis. Stats. The major focuses of our audit were to assess the effectiveness of the Office in regulating state-chartered banks and consumer credit agencies, review the Office's fiscal operations, and determine its compliance with statutory requirements.

Overall, the Office appears to be effective in regulating the banking and consumer credit industries. However, we found the Office has not complied with several statutory requirements. In its regulation activities, the Office has not met the required annual bank examination schedule and has not provided statutorily required information on its regulation of consumer credit. The Office also has not consistently complied with state purchasing guidelines. As a result, the Office spent \$4,379 more than necessary in the purchase of computer software and made an unauthorized purchase of over \$13,000 in computers and software.

In addition, the Office needs to modify and monitor its fee setting process to ensure examination fees cover direct examination costs, as required by the statutes, and large cash balances, such as the fiscal year 1987-88 year-end balance of \$1.1 million, are considered in the establishment of bank assessment rates.
