To the Honorable the Legislature:

We have completed an evaluation of the Nonpoint Source Pollution Abatement and the Soil and Water Resource Management Programs, as required by 1987 Wisconsin Act 27. We assessed the degree to which the Department of Natural Resources (DNR) and the Department of Agriculture, Trade and Consumer Protection (DATCP) have implemented changes mandated in 1987, regarding coordination, evaluation and financial management of the two programs.

Inadequate budgeting practices and slower-than-expected project planning have resulted in not spending all the funds appropriated for the nonpoint program. We estimate the program will have a balance of at least \$10 million general purpose revenue (GPR) at the end of fiscal year (FY) 1988-89. DNR officials now believe they will be able to accelerated the project planning process to effectively use the balance and new appropriations for future projects. Even if \$3 million is transferred from the program to the Clean Water Fund, as recommended by the Governor, DNR will not commit all available funds to projects before the end of the 1989-91 biennium.

Although DNR and DACTP are cooperating in devising new procedures implementing the mandated coordination of their programs, revised administrative rules codifying the coordinated procedures are not yet in a form which will ensure their successful implementation. In a separate letter, we have provided recommendations to the departments for changes to the draft rules which are to be submitted to the Legislature in June.

Finally, the programs' evaluation plan, devised jointly by DATCP and DNR, will need some revision to ensure the evaluation required by statute is produced. The actual scope of the program evaluation may be

limited because of the limited staff resources assigned by DNR to water quality monitoring.

We appreciate the courtesy and cooperation extended to us by staff of both departments, and by the county conservation staff we contacted. Responses from the departments are Appendices II and III.

To the Honorable the Legislature:

We have completed an audit of the Wisconsin Conservation Corps (WCC) program, which was created in 1983, to satisfy our responsibilities under s. 13.94, Wis. Stats. The major focuses of our audit were to review WCC's fiscal operations and determine its compliance with statutory requirements. We also reviewed the selection and management of conservation projects.

Overall, we found the WCC's fiscal affairs were carried out in a satisfactory manner and that WCC was generally effective in its administration of the program. However, WCC needs to modify its policies and procedures for paying incentive bonuses to promote the effectiveness of the bonus incentive and ensure compliance with statutory provisions. In addition, WCC needs to improve its monitoring of sponsor contributions and further document its achievement of the statutory requirement of hiring 50 percent of its corps members from among those persons eligible to receive public assistance.

A WCC Energy Conservation Team, which is currently funded with \$2 million from the federal Stripper Well Oil Overcharge Settlement Agreement, was created in 1987 to perform weatherization and conservation work on government and nonprofit facilities. In its first seven months of operation, the Energy Team experienced numerous program difficulties, including alleged theft by a crew leader and low attendance and high attrition by corps members. WCC has subsequently begun making several changes to address these problems and improve operations.

We appreciate the courtesy and cooperation extended to us by the WCC staff and enrollees. WCC's response to the report is the Appendix.

We have completed a financial and compliance audit of the University of Wisconsin-Oshkosh's student financial assistance programs as required by federal

regulations and as requested by the University of Wisconsin System. We also included the state grants in our awards testing for compliance with state statutes as requested by the Wisconsin Higher Educational Aids Board. Our audit period was July 1, 1986, through June 30, 1988.

The first and second sections of our report contain the University's student financial assistance programs' financial statements and the related independent auditor's opinion. The third and fourth sections contain the auditor's statement on internal control systems and statement on compliance, as well as our comments on control deficiencies and findings noncompliance The fifth section contains our comments on the status of the recommendations made during the prior audit of the federal student financial assistance programs conducted by University of Wisconsin System-Internal Audit, our prior audit (88-8) of the Nursing Student Loan program and a federal follow-up audit.

Except for questioned costs of \$445 and minor compliance errors, we found the University of Wisconsin-Oshkosh administered the student financial assistance programs as required by federal regulations and state statutes. The primary area of noncompliance with federal regulations was the incorrect allocation of refunds for the tuition and fees of students who withdrew from the University during the semester.

We appreciate the courtesy and cooperation extended to us by the University of Wisconsin-Oshkosh staff during our audit. The University's comments on individual audit findings are within the body of our report and its overall response is the Appendix.

To the Honorable the Legislature:

We have completed a review of selected University of Wisconsin faculty and academic staff salary issues, as requested. The University has requested salary increases totaling \$194 million in the 1989-91 biennial budget, including \$63.6 million in catch-up increases. These funds would allow salaries to be increased to the median salaries paid to faculty and staff at peer institutions throughout the nation.

University officials have argued that without these increases recruitment and retention of faculty will be difficult. We found, however, that while the University's median faculty salaries have been consistently below its peer groups' medians since 1977-78, the annual rate of faculty turnover has remained at approximately 4 percent, suggesting that faculty make job decisions on a

number of factors. Therefore, unless there is evidence that turnover is likely to increase or that recruiting is becoming a problem, it would appear difficult to conclude that faculty salaries must be increased to the median of the peer institutions to avoid a major increase in faculty resignations throughout the system.

The Legislature will need to decide whether other considerations justify the level of funding requested or, alternatively, whether a salary distribution plan which addresses high priority needs will accomplish the major recruitment and retention objectives at a lesser cost. Improvement over the distribution of catch-up provided in the 1985-87 biennium would appear in order, since institutions were given considerable latitude in distributing catch-up funds and varied widely in the extent to which salary increases were based on competitive market and individual merit considerations.

Our analysis of current salaries for non-instructional academic staff indicates that it may not be necessary to provide increases based on comparisons with salaries paid by institutions throughout the nation. Only a limited number of these positions are recruited from other universities or from outside Wisconsin or this region, and retention has not been a problem.

We appreciate the courtesy and cooperation extended to us by University of Wisconsin System and campus staff. The University's response is Appendix II.
