To the Honorable the Legislature:

We have completed an audit of the Capital Improvement Fund and of the Bond Security and Redemption Fund for the 1988 calendar year, as required by s.18.10(3), Wis. Stats. Our audit also included a determination of the State's aggregate net indebtedness on December 31, 1988, as required by s.18.05(3), Wis. Stats.

We found that the State's net indebtedness on December 31, 1988, of \$2.47 billion and the debt contracted during the year of \$507 million were within the State's constitutional debt limitations. In addition, our audit did not disclose any transactions which were improper or which materially misstated state records.

We appreciate the courtesy and cooperation extended to us by the staff of the Department of Administration.

State of Wisconsin Legislative Audit Bureau

To the Honorable the Legislature:

We have completed a financial and compliance audit of the University of Wisconsin-Stevens Point's student financial assistance programs as required by federal regulations and as requested by the University Wisconsin System. We also included the state grants in our awards testing for compliance with state statutes as requested by the Wisconsin Higher Educational Aids Board. Our audit period was July 1, 1986, through June 30, 1988.

The first and second sections of our report contain the University's student financial assistance programs' financial statements and the related independent auditor's opinion. The third and fourth sections contain the auditor's statement on internal control deficiencies and findings of noncompliance. The fifth section contains our comments on the status of the recommendations made during the prior audit conducted by University of Wisconsin-System Internal Audit.

Except for questioned costs of \$1,094 and minor compliance errors, we found the University of Wisconsin-Stevens Point administrated the student linancial assistance programs as required by federal regulations and state statutes. The primary area of noncompliance with federal regulations was the delayed transfer of the state match for the Perkins Loan program, which resulted in lost investment earnings for the Perkins Loan fund.

We appreciate the courtesy and cooperation extended to us by the University of Wisconsin-Stevens Point staff during our audit. The University's comments on individual audit findings are within the body of our report, and its overall response is the Appendix.
