**REPORT OF JOINT SURVEY COMMITTEE ON  
RETIREMENT SYSTEMS**

**Appendix to Senate Bill 195**

**Public Policy Involved**

Prior to 1971, the three retirement funds administered by the state each had separate and different provisions for the crediting of military service. A major study by the Retirement Research Committee (Report #21-1970) recommended a standardization of the military crediting

provisions for the state funds, and these recommendations were enacted by the 1971 legislature. These recommendations provided that the military service had to be under specified branches as currently defined in s. 40.02(15)(a). The RRC recommendations further provided that such military service would only be credited if it were a break in covered public employment.

During the same 1971 legislative session, the crediting of military service which is not a break in public employment was first granted to state employees under the old WRF. These provisions governing the crediting of non-intervention military service were expanded in 1973, 1982, 1984 and 1987. This bill would further amend the provisions governing recognition of military service which is not a break in public employment.

This bill presumably reflects the U.S. Dept. of Defense action on January 11, 1988, adopting procedures to recognize American merchant marine service during 12/7/41 to 8/15/45 as active duty for purposes of all laws governing the U.S. Veteran's Administration. The new policy provides that a certificate of release or discharge from active duty or an honorable service certificate shall be provided to each qualifying member of the merchant marine, the U.S. Army Transport Service, and the U.S. Naval Transport Service upon receipt of an application and verification of the creditable service meeting the following criteria:

1. Was employed by the War Shipping Administration or Office Defense Transportation or their agents as a merchant seaman documented by the U.S. Coast Guard or Department of Commerce (Merchant Mariner's Document/Certificate of Service), or as a civil servant employed by the U.S. Army Transport Service (later redesignated U.S. Army Transportation Corps., Water Division) or the Naval Transportation Service; and
2. Served satisfactorily as a crew member during the period of armed conflict, December 7, 1941, to August 15, 1945, aboard -
  - (a) merchant vessels in oceangoing, i.e., foreign, intercostal, or coastwise service (46 USCA 10301 and 10501) and further to include "near foreign" voyages between the United States and Canada, Mexico or the West Indies via ocean routes, or
  - (b) public vessels in oceangoing service or foreign waters."

Presently, the WRS is nearly unique in granting service credit for military service which is not a break in public employment at no cost to the employee. This bill expands the crediting provisions, reflecting recent Federal court and U.S. Dept. of Defense actions to place

merchant marine service on the same footing as other recognized branches of the U.S. Armed forces.

### RECOMMENDATION

The Joint Survey Committee on Retirement Systems finds that **Senate Bill 195**, as amended by Senate amendment 1, represents good public policy and recommends its passage.

To the Honorable the Legislature:

We have completed our evaluation of the Division of Safety and Buildings in the Department of Industry, Labor and Human Relations (DILHR), as requested by the Joint Legislative Audit Committee. We evaluated whether the Division has, in recent years, changed its level of enforcement of state safety regulations of commercial building and private sewage systems.

Our review shows a general decline in those indicators which traditionally signify enforcement effort. The percentage of building plans denied because they did not comply with safety regulations has decreased, and approvals of variances to safety regulations have increased sharply. There are similar declining trends in enforcement action. The number of violations cited, departmental orders for corrective action and referrals to the Attorney General's office for prosecution have all declined.

There is considerable difficulty in gauging the immediate effect safety regulations, or lack of compliance with safety regulations, have on public safety; i.e. buildings with inadequate firewalls do not necessarily catch fire. Consequently, there is considerable disagreement over the meaning of the declining trends in enforcement action.

Division officials believe these trends are due to increased voluntary compliance by the building industry and are a result of the Division's policy of cooperation and flexibility to reach compliance. On the other hand, some Division staff, and other professionals in the field, believe the Division has established a new pattern of interpretation of safety questions which is, or creates the appearance of being, less strict than in the past.

We also found that the Division has made some management improvements, especially in more prompt processing of building plan reviews and requests to use new products. However, we believe improved oversight of safety regulatory decisions is necessary to protect the credibility of the enforcement program. For the Division to establish accountability, we include recommendations for improved management oversight of plan reviews, improved documentation of decisions and improved monitoring of compliance with corrective orders.

We appreciate the courtesy and cooperation extended to us by the Department of Industry, Labor and Human Relations staff and the many county and local officials

To the Honorable the Legislature:

We have completed an evaluation of the transportation costs for the Chapter 220 program in metropolitan Milwaukee, as requested by the Joint Legislative Audit Committee. The Chapter 220 program provides financial incentives for school districts to desegregate schools. Transportation costs for fiscal year (FY) 1988-89 totaled \$18.7 million.

Transportation costs have increased dramatically since FY 1981-82 and will continue to increase through FY 1992-93 to an estimated \$25.2 million. Transportation costs for the Chapter 220 program are high because the program allows students to choose to attend schools outside their neighborhood provided their choice enhances the racial balance of the school they chose.

We reviewed Milwaukee Public Schools' (MPS) responsibilities for providing transportation services for the Chapter 220 program. MPS uses a computerized system for school bus route design and a competitive bidding process to award contracts to private bus companies. Both processes help control transportation costs.

Some cost savings are likely to occur provided Milwaukee Public Schools and 23 suburban school districts participation in the program cooperate in changing some policies which are contributing to higher transportation costs. Cooperation is needed to establish a uniform definition of extracurricular activities which qualify for transportation to be paid from Chapter 220 funds and to coordinate, where possible, school start and end times and school calendars among districts so as to make more efficient use of school buses. In addition, reimbursement limits on school bus costs could be considered for suburban school districts which award bus contracts outside the MPS competitive bidding process.

We appreciate the courtesy and cooperation we received from staff at MPS and the Department of Public Instruction and from officials and staff of suburban school districts.

To the Honorable the Legislature:

In accordance with s. 619.15(2), Wis. Stats., I am pleased to submit to you the annual report for calendar year 1988 for the Health Insurance Risk Sharing Plan. This report is for distribution to the Standing Committees on Insurance. The Plan was established in 1981, and, as of December 31, 1988, insured 3,350 Wisconsin residents.

Major activities during 1988 included:

- Issuing 2,208 new policies. This was a 104% increase over 1987.
  - Assessing insurers. Insurers were assessed \$1.9 million in 1988 to make up for the difference between the expenses of the Plan and premiums collected. From 1981 to 1988, insurers have been assessed \$9 million.
  - Conducting a survey of policyholders. It shows that 54% of respondents are female. Sixty percent are married. Twenty-eight percent have incomes below \$12,000 a year and 53% reported that they are unemployed.
  - Implementing a cost containment program. Act 27, 1987 required the Insurance Commissioner to implement cost containment provisions. Those provisions are now in effect.
- Implemented the deductible subsidy. The deductible subsidy took effect on January 1, 1988. As of December 31, 1988, 871 enrollees were receiving the premium and deductible subsidy.
- Maintaining premium rates at their 1985 level. This has contributed greatly to increased enrollment by attracting enrollees who otherwise may have sought insurance in the private market.

We have attached excerpts from the Plan Administrator's annual report to the Board of Governors. I hope this provides you with information that will assist you in making informed decisions on health insurance issues.

The report also describes the "Insuring Firm" pilot, scheduled for start-up in September 1989, and the "Alternative Health Care Coverage Pilot", scheduled for start-up in October 1989.

On January 1, 1990 the Department will submit a second progress report, describing the status of each pilot project, the number of persons enrolled and the amount of funds expended for subsidies and administration.
