Attached, pursuant to s. 227.24(3), Stats., is a copy of emergency rules relating to the learning assistance program. These emergency rules were promulagated by the Department effective September 18, 1989.

1989 Wisconsin Act 31 created s. 115.363, Stats., which provides grants to school districts for learning assistance programs. Section 115.363(6), Stats., specifies that, in the 1989-90 school year, \$434,000 (the entire 1989-90 appropriation) must be awarded to school districts which have a membership of less than 12,000 in which more than 3.5% of the membership consists of limited-English speaking pupils from Indo-Chinese language groups.

The emergency rules specify that the grants must be used to provide services to limited-English speaking pupils from Indo-Chinese language groups, specify some of the permitted uses of the grant and set a maximum of 5% for administration of the program. In addition, the rules prohibit using the grants to pay for costs which are reimburseable under s. 115.995, Stats.

Because the emergency rules are limited to implementing the portion of the grant program which applies only to programs for limited-English speaking pupils from Indo-Chinese language groups in the 1989-90 school year, they will not be promulgated as permanent rules. Instead, the Department will prepare proposed permanent rules which are intended to administer the entire grant program beginning in the 1990-91 school year, which will include some of the provisions of these emergency rules.

A public hearing on the emergency rules has been scheduled for October 16, 1989. It will be held from 7:00-7:300 p.m. in Room 041 of GEF 3, 125 South Webster Street, Madison.
