We have completed an audit of the Children at Risk program as required by s. 118.153, Wis. Stats. The audit was of the second year of the program's operation and concentrated on implementation of prior recommendations made to the Department of Public Instruction regarding first-year program implementation and on Department review of school district children atrisk programs for the 1987-88 school year.

Overall, school districts continue to demonstrate increased effort to comply with children at-risk program requirements and procedures. However, in 15 of the 31 districts required to submit plans and annual performance reports to the Department of Public Instruction, at-risk students failed to meet three of five statutory performance criteria, thus preventing those districts from receiving additional state aid.

The Department did implement our recommendations regarding clarification of identification procedures, documentation of attendance rates, and earlier plan submission. We also reviewed the method used to define average per pupil costs for determining Milwaukee Public School District's payments iprivate service providers and it appears reasonable.

We note the Department has not yet revised its administrative rules concerning notifying the parent or guardian if a child is enrolled in an at-risk program. We also include a recommendation for the Department to further improve its on-site review of district children atrisk programs by reviewing samples of individual pupil records to ensure proper program implementation.
