Whereas, Bonnie Reese, a native of Logan, Utah, graduated from Utah State University, where, by winning a scholarship, being accepted by honorary organizations, being elected president of her sorority and secretary of her senior class, graduating in the top of her class and being designated the outstanding woman graduate, she demonstrated the intellectual acuity and talent for leadership that would later be invaluable to the Wisconsin legislature; and

Whereas, she received a master's degree in Political Science and Public Administration from the University of Wisconsin-Madison and served as the assistant to the Director of the University of Wisconsin - Extension's Institute of Governmental Affairs; and

Whereas, aside from one year at the Extension, she devoted her entire professional career to the Legislative Council, beginning as a Research Assistant in 1957, becoming a Senior Policy Analyst in 1968 and becoming Director in 1971; and

Whereas, during her long tenure at the Legislative Council she supplied the legislature with many perceptive analyses of complex issues, for example doing crucial staff work on the development of the state's school aid formula and the creation of the University of Wisconsin system; and

Whereas, she has played a key role in the development of staff services offered to the legislature by completing the transformation of the Legislative Council from a small agency concerned mainly with interim study committees to a larger agency that provides a broad, full-time range of sophisticated services and by building, maintaining and guiding a highly skilled and dedicated staff; and

Whereas, she strongly believes in the legislature as an institution and dedicated herself to strengthening it as a coequal branch of government by serving as staff to the Joint Committee on Legislative Organization, participating in numerous special projects, assuming organizational responsibility for numerous conferences and other activities undertaken by the legislative branch and generously providing advice and counsel to generations of legislators; and

Whereas, Bonnie Reese has been a trailblazer by becoming the first woman to head a major state agency in Wisconsin and the first woman to serve as the head of the staff section of the National Conference of State Legislatures; and

Whereas, she held many high offices in the National Conference of State Legislatures and was a Distinguished Consultant to the University of Wisconsin-Madison when it established the La Follette Institute; and

Whereas, she received the Distinguished Service Award in 1985 from her alma mater. Utah State University, in recognition of her years of service, including membership in the University's National Advisory Council: and

Whereas, because of these and other achievements she has been the quintessential legislative staff member; now, therefore, be it

RULING OF THE CHAIR

Senator Davis raised a point of order that senate substitute amendment 2 as introduced and as amended was non-germane.

The amendments to senate substitute amendment 2 which have been adopted are senate amendments 1 and 2. Senate amendment 1 clarifies current law to insure the immunization program applies to Milwaukee School systems. Senate amendment 2 has changed an effective date.

Senate substitute amendment 2 amends an appropriation as does the original bill. It is true as the Senator Davis indicates the original relating clause did not contain that cite however, in the body of 1989 October Special Session Senate Bill 13 the same section of the statutes is enumerated. I point this out only to remind the body that the President cannot rely on a title of a bill to determine the subject. Also, I might point out that the analysis of the original bill discusses responsibilities of governing bodies and various schools as they relate to immunization. Mason's Manual Sec. 402(2) states:

To determine whether an amendment is germane, the question to be answered is whether the question is relevant, appropriate, and in a natural and logical sequence to the subject matter of the original proposal.

The Chair is of the opinion that 1989 October Special Session Senate Bill 13 as originally drafted provides increased funding for the immunization program for school age children senate substitute amendment 2 as amended stays within this scope. Therefore it is the opinion of the Chair the amendment is germane and the Point of Order is not well taken.
