#### THE BOARD FINDS:

- Douglas and Mary Ikeler of Caledoniam Wisconsin claim \$6,820.65 for damages allegedly incurred as a result of faulty installation of a roof on a home they purchased from the Department of Veterans Affairs in October, 1985. The Department of Veterans Affairs contracted for installation of a new roof and other repairs in order to comply with the contingencies set forth in a Veterans Administration appraisal of the property. In December, 1985, the new roof was installed and found to be satisfactory by the Federal Veterans Administration inspector. In July, 1986, water leaked through the roof damaging claimants' personal property. The Board concludes the claim should more appropriately be dealt with in court and therefore, denies payment of this claim so this matter may be litigated in court. (Member Wilker not participating).
- 2. Milwaukee County Election Commission claims \$62,438.00 for the cost of reprinting ballots for the November 8, 1988 general election in the cities of Shorewood and Milwaukee. On October 12, 1988, the Elections Board ordered claimant to cease printing its November, 1988 general election ballots because they did not comply with s. 5.64, Wis. Stats. The Elections Board determined that there was a likelihood electors would inadvertently neglect to cast their vote for President due to the design of the ballots. The notice to claimant that

its ballots were defective and would have to be reprinted was less than 28 days before the November 8 election, after a substantial portion of the ballots had already been printed. The Board recommends the claim be paid in the reduced amount of \$50,119.00, which represents the actual cost to claimant for the destroyed ballots. The Board also recommends payment of claims from other similarly affected counties, upon submission of appropriate documentation from those counties. The Board further recommends under the authority of s. 16.007(6m), Stats., the claims should be paid from the Claims Board appropriation s. 20.505(4)(d), Stats.

- 3. Dorothy Brode of Brookfield, Wisconsin, claims \$8.168.60 for replacement cost of her vehicle and loss of income allegedly incurred when her vehicle was damaged by a tree limb at the State Fair Park in West Allis on July 27, 1989. During a storm with winds up to 45 mph, the tree limb fell on top of claimant's car while it was parked at the Fair, totaling the vehicle. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 4. Jan Eder of Whitefish Bay, Wisconsin, claims \$806.00 as the amount charged to his bank account for a state AFDC check on which the state had stopped payment. In August, 1986, claimant's tenant, Helen Ensley, gave claimant her AFDC check in the amount of \$806 for payment of rent. When claimant cashed the check, he returned \$356 to Ms. Ensley and kept \$450 for rent. The state stopped payment on the check because Ms. Ensley filled out an affidavit that the check was lost. As a result, claimant's bank account was charged \$806. In September, 1989, claimant was reimbursed \$450 from the Department of Health and Social Services. Board concludes the claim should be paid in the reduced amount of \$356.00, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(6)(a), Stats.
- Marilyn Arneson of Barneveld, Wisconsin, claims \$1,997.96 for the difference between wages carned and the amount she would have earned if her position had been reclassified to a Management Information Technician 2 (MIT-2) from April 20, 1988 to the present. Claimant is employed as a Typesetting System Input Operator 2 (TSIO-2) in the Duplicating Services Unit at the University of Wisconsin-Extension. contends that other individuals doing substantially equivalent work are classified as MITs-2 and are paid at a higher rate. In April, 1988, claimant requested reclassification of her position. The Department of Employment Relations reviewed claimant's position and determined, based on existing classification plans, her position was correctly classified and denied the reclassification request on November 9, 1988. Claimant appealed the decision to the Personnel Commission,

- which sustained the action of the Department of Employment Relations on technical grounds, although noting an apparent inequity in the situation. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- Susan Lulling of Wannakee, Wisconsin, claims \$8,494,63 for the difference between wages carned and the amount she would have earned if her position had been reclassified to a Management Information Technician 3 (MIT-3) from April 20, 1988 to the present. Claimant is employed as a Typesetting System Input Operator 2 (TSIO-2) in the Duplicating Services Unit at the University of Wisconsin-Extension. contends that other individuals doing substantially equivalent work are classified as MITs-2 and are paid at a higher rate. In April, 1988, claimant requested reclassification of her position. The Department of Employment Relations reviewed claimant's position and determined, based on existing classification plans, her position was correctly classified and denied the reclassification request on November 9, 1988. Claimant appealed the decision to the Personnel Commission. which sustained the action of the Department of Employment Relations on technical grounds, although noting an apparent inequity in the situation. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 7. Timothy Jordan of Franklin, Wisconsin, claims \$119.00 for replacement of his eyeglasses allegedly damaged on August 1, 1989, at the State Fair Park. Claimant was unloading park benches from a trailer when one of the benches fell off the trailer hitting him in the face, smashing his eyeglasses. The damage occurred while claimant was engaged in his duties as a State Fair Park employe. The Board concludes the claim should be paid, based on equitable principles. The Board further concludes under the authority of s. 16.007(6m), Stats. payment should be made from the State Fair Park appropriation s. 20.115(5)(h), Stats.
- 8. William Brockman of Oak Creek, Wisconsin, claims \$84.00 for mileage, meals and a phone call allegedly resulting form the State Job Service's negligence in failing to inform him of a typing requirement when scheduling his interview for an Employment Security Assistant position in La Crosse. On July 26, 1989, claimant arrived at the La Crosse Job Service Office to interview for the position and was then informed that the job was a secretarial position requiring typing ability. Claimant was not qualified for the position and contends that if he had been advised of the typing requirement when Job Service informed him of the position, he would not have accepted the interview. The Board concludes the claim should be paid, based on

equitable principles. The Board further concludes under the authority of s. 16.007(6m), Stats., payment should be made from the Department of Industry, Labor and Human Relations appropriation s. 20.445(1)(ga), Stats.

- 9. Orris Boettcher of Middleton Wisconsin claims \$8,000.00 for military service credit benefits from July. 1980 to January, 1990. Claimant retired in June, 1980 and began receiving his retirement annuity on July 1. 1980. Claimant's retirement annuity was granted under the Wisconsin State Teachers Retirement System (STRS) which provided active military service credit only if teaching service was interrupted for military service and there was a return to employment covered by the STRS within 180 days of discharge, Claimant did not qualify for the credit of his active military service because he first began employment as a teacher under the STRS seven years after his discharge from the military service. As part of the merger of STRS into the Wisconsin Retirement System (WRS) on January 1, 1982, teachers became eligible for more liberal crediting of military service under s. 40.02(15), Stats. Claimant would have qualified for additional creditable service based on his military experience if he had remained employed and had retired on or after January 1, 1981. The statute in effect on the date claimant applied for an annuity from WRS did not permit the crediting of his active military service. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 10. Thomas Parrott of Stratford, Wisconsin, claims \$49.95 for replacement cost of his Ray-Ban sunglasses allegedly lost on July 26, 1989, while he was on duty as a trooper for the Wisconsin State Patrol. Claimant laid his sunglasses on the passenger side front seat of his cruiser. When in pursuit of an individual for operating while under the influence, claimant's glasses slid off the front seat onto the door ledge on the floor. Claimant believes the glasses fell out of the cruiser when he placed the individual he was arresting into the cruiser. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 11. Milton Ver Doot of Green Bay, Wisconsin, claims \$180.00 for attorney fees and mileage, allegedly incurred as a result of a citation he received on February 28, 1989, for improper registration of his vehicle. Claimant had stopped his vehicle on Interstate 90-94 to check for a flat tire. A state patrol car stopped to see if claimant needed assistance. The trooper noticed claimant's vehicle had auto plates but contained only two front bucket seats and therefore, should have been registered as a truck. The trooper issued a citation to claimant for this violation. Claimant retained an attorney and as a result of a plea agreement with the court, the charge was dismissed after claimant re-

- registered his van with truck plates. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- Margaret Main of Mena, Arkansas, claims \$116.95 as the difference between her real estate taxes for 1987 and 1988, and the amount that would have been due if her land in Washburn County, Wisconsin, had been properly entered under the Managed Forest Law program (MFL). Due to a data entry error by the Department of Natural Resources, the original MFL order erroneously omitted five acres of eligible land for which an application had been made. Although the error has now been corrected, it resulted in claimant's overnayment of taxes for the years 1987 and 1988. The Board concludes the claim should be paid in the reduced amount of \$91.06. The Board further concludes under the authority of s. 16.007(6m), Stats., payment should be made from the Department of Natural Resources appropriation s. 20.370(1)(mu). Stats.
- 13. Patricia Peterson of Green Bay, Wisconsin, claims \$156.37 for medical expenses incurred as a result of an injury she allegedly sustained on May 6, 1989, when she fell at the Heritage Hill State Park. Claimant injured her knee when she slipped and fell on some gravel on a road in the park. Section 895.52, Stats., limits liability for damages resulting from the use of state-owned recreational facilities under these circumstances in the absence of the showing of a malicious act or malicious failure to warn of a known unsafe condition. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 14. Jackie Klar of Cuba City, Wisconsin, claims \$58.46 for replacement of her eyeglasses, allegedly damaged while she was employed as a work-study student at the Yellowstone State Park in August, 1989. The glasses were damaged when they fell off the top of a pick-up truck where claimant had placed them. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 15. Steven Tuohy of Chisholm, Minnesota, claims \$142.00, plus interest, for his 1985 income tax refund which was retained by the Wisconsin Department of Revenue and applied to estimated tax assessments for the years 1981, 1982 and 1983. In June, 1988, claimant provided information to the Department of Revenue to prove that no income tax liability existed for 1981 through 1983, because he was a New York domiciliary, on active duty with the Coast Guard while residing in Wisconsin and therefore, exempt from Wisconsin income

taxes received from the Coast Guard. The Board concludes the claim should be paid in the amount of \$142.00 based on equitable principles. The Board further concluded under authority of s. 16.007(6m), Stats., payment should be made from the Claims Board appropriation s. 20.505(4)(d), Stats.

- 16. Galen Brainerd of Bruce, Wisconsin, claims \$1,277.00 for reimbursement of his 1975, 1984, 1985, 1986 and 1987 tax refunds withheld by the Department of Revenue for an estimated assessment issued to him in September 1975, for failure to file tax returns for 1972 and 1973. On February 24, 1989, claimant filed his tax returns for 1972 and 1973 which indicated a tax liability of \$143.20 plus interest. A claim for refund must be filed with the Department of Revenue within two years after the assessment pursuant to s. 71.75(5), Stats. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 17. Alois Fischer of Appleton, Wisconsin, claims \$379.86 as payment of witness fees for his appearance at a John Doe proceeding in Dane County Circuit Court in Department of Revenue tax agents, Dennis Ullman and Charles Wnukowski, served subpoenas on claimant ordering him to appear at the John Doe hearings on February 3, 1984 and May 16, 1984. Claimant appeared as ordered. The Doe investigation resulted in criminal tax charges filed against Diane Wickstrom. Claimant contends he should be reimbursed for his lost wages, mileage and meals for his appearance. If claimant had made proper application for witness fees, he would have been reimbursed at the rate provided by s. 814.67(1), Stats. Tax agents Ullman and Wnukowski were at all times performing their official duties as agents of the Wisconsin Department of Revenue in accordance with the John Doe Access Order. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 18. Nadim Sahar of New Berlin, Wisconsin, claims \$206.03 for damages to his automobile allegedly incurred on October 2, 1989, when entering the parking lot at the Milwaukee State Office Building. Claimant attempted to turn into the lot when a garbage truck was exiting. The parking lot gate was in the up position, so claimant started to drive through. At the same time, the garbage truck started to back up to let claimant into the lot. The gate came down on top of claimant's vehicle because he did not use his access card, since the truck was blocking the card reader. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles. (Member Wilker not participating)

- 19. Kurt Larson of Sun Prairie, Wisconsin, claims \$92.59 for replacement of his car window allegedly damaged on November 6, 1989, by an unknown person while the vehicle was parked in the Department of Administration Central Printing lot at 202 South Thornton Avenue, Madison, where claimant is employed. When claimant returned to his vehicle after work, he discovered the passenger side window had been The Board concludes there has been an smashed. insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 20. Connie LaVon Lee of La Crosse, Wisconsin, claims \$35.00 for replacement of her blouse allegedly damaged on November 3, 1989, at a Department of Transportation office in La Crosse. As claimant walked out of an office, the sleeve on her blouse became caught on a piece of tile protruding from the wall. The Building Superintendent has corrected the problem. The Board concludes the claim should be paid based on equitable principles. The Board further concluded under authority of s. 16.007(6m), Stats., payment should be made from the Department of Administration appropriation s. 20.505(5)(ka), Stats.
- 21. Allan Kasprzak of Milwaukee, Wisconsin, claims \$168.19 for replacement cost of his car antenna allegedly damaged on October 5, 1989, by the gate at the entrance of the Milwaukee State Office building parking lot. The timing on a relay switch was incorrectly set causing the gate to stay in the up position after a carded sequence was completed. Claimant assumed the gate was locked open, however, as he drove into the lot, the gate came down on top of his car. The timing on the relay switch has been corrected and the card reader system is now functioning properly. The Board concludes the claim should be paid based on equitable principles. The Board further concluded under authority of s. 16.007(6m), Stats., payment should be made from the Department of Administration appropriation s. 20.505(5)(ka), Stats.
- 22. Bonnie Landgraf of Madison, Wisconsin, claims \$56.00 for replacement of two skirts allegedly damaged while they were in the trunk of a state vehicle she was using on August 7-11, 1989. Claimant alleges that a mouse or similar creature in the trunk of the state vehicle chewed holes in her garment bag and clothing. The Department of Administration Fleet manager inspected the vehicle and did not find a mouse or anything else, but did notice holes in the trunk mat. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 23. Grace Luhman of Goodhue, Minnesota, claims \$158.80 for medical expenses allegedly resulting from an injury she sustained on April 3, 1989, during a metals

class at the University of Wisconsin-River Falls. After claimant turned on the power for a hacksaw, the machine came forward and cut her thumb. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.

- 24 McKay Nursery Company of Waterloo. Wisconsin, claims \$93.47 for repairing a video player and T.V. monitor, allegedly damaged while plugged into a temporary electrical outlet at the University of Wisconsin-Madison Stock Pavilion on September 12. 1989. Claimant was participating in the Agricultural and Life Science Career Day Show and was using the temporary outlet when a connection in the power supply cord became loose causing voltage fluctuations. The voltage fluctuations damaged claimant's appliances. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 25. Janice Timm of Irma, Wisconsin, claims \$68.00 for replacement of a baseball glove and batting glove allegedly stolen by an unknown person from the women's locker room at the University of Wisconsin-River Falls. Claimant kept her sports equipment n an assigned locker in the women's locker room. During the weekend of December 2, 1988, the women's locker room was used by a visiting wrestling team. Sometime during the weekend, the locker was broken into and claimant's personal belongings were stolen. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 26. Starlyn Minke of River Falls, Wisconsin, claims \$458.49 for replacement of sports equipment allegedly stolen by an unknown person from the women's locker room at the University of Wisconsin-River Falls. Claimant kept her sports equipment in an assigned locker in the women's locker room. During the weekend of December 2, 1988, the women's locker was used by a visiting wrestling team. Sometime during the weekend, the locker was broken into and claimant's personal belongings were stolen. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 27. Debbie Gaunitz of River Falls, Wisconsin, claims \$178.00 for replacement of her sports equipment allegedly stolen by an unknown person from the women's locker room at the University of Wisconsin-River Falls. Claimant kept her sports equipment in an

- assigned locker in the women's locker room. During the weekend of December 2, 1988, the women's locker was used by a visiting wrestling team. Sometime during the weekend, the locker was broken into and claimant's personal belongings were stolen. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 28. Robert Grabarce of Waterford, Wisconsin, claims \$45.00 for replacement of his athletic shoes allegedly stolen by an unknown person from a locker in the maintenance building at the Southern Wisconsin Center on July 1, 1989. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 29. Gregory McRae of Racine, Wisconsin, claims \$65.95 for replacement of his athletic shoes allegedly stolen by an unknown person from a locker in the maintenance building at the Southern Wisconsin Center on July 1, 1989. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 30. Michael Geer of Stanely, Wisconsin, claims \$180.63 for replacement of his vehicle windshield allegedly damaged by a rock thrown from a lawn mower being operated by a maintenance employe at the Northern Wisconsin Center on June 2, 1989. The total amount claimed has been paid by claimant's insurance company, General Casualty Company. Consistent with the long-standing policy of this Board concerning subrogation claims, the Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 31. Horace Stephens, Jr. of Plymouth, Wisconsin, claims \$230.00 for replacement of a plastic decanter, cassette tapes and a gold diamond ring allegedly lost when he was transferred from the Marshall E. Sherrer Correctional Center to the Kettle Moraine Correctional Institution (KMCI) on January 14, 1986. The Institution's property inventory records indicate that one pitcher and five tapes were inventoried upon claimant's admission to KMCI in January, 1986. The KMCI Handbook states that an inmate should not have any item of jewelry worth more than \$75 and that the Institution is not responsible for any item worth more than \$75. Claimant signed a statement absolving KMCI of responsibility for any article worth more than \$75.

The Board concludes the claim should be paid in the reduced amount of \$75.00 based on equitable principles. The Board further concluded under authority of s. [6.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.410(1)(a), Stats.

- 32. Alice Laubenstein of Kewaskum, Wisconsin, claims \$157.47 for replacement of her coat allegedly stolen from the Southern Wisconsin Center, where she was attending a conference on October 6, 1989. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 33. Raymond Cole of Union Grove, Wisconsin, claims \$128.00 as the amount of money allegedly stolen by a resident of the Southern Wisconsin Center, where claimant is employed. On August 25, 1989, claimant left his wallet containing \$200, on the seat of his unoccupied truck; a resident of the Center allegedly took the wallet. The wallet and \$72 was later returned to claimant. The Board concludes there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally fiable, nor one which the state should assume and pay based on equitable principles.
- 34. Larry Uhazie of Waupun, Wisconsin, claims \$551.14 for reimbursement of 12 days wages and reinstatement of vacation, holiday and sick leave benefits under s. 230.36, Stats., while he was recovering from an injury. Claimant is employed as a correctional officer at the Dodge Correctional Institution and injured his knee while attending an authorized SWAT training session on July 14, 1989. Participation in training activities is not a hazardous duty specified for coverage under s. 230.36(3)(c), Stats. The current agreement with the Wisconsin State Employees Union for represented employes expands hazardous duty pay to include injuries sustained during "crowd control, self-defense or riot training activities." If claimant were a represented employe, he could rely on that contract language to claim hazardous duty pay. The Board concludes the claim should be paid in the reduced amount of \$100.00 based on equitable principles. The Board further concluded under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.410(1)(a), Stats.

In addition, the following claim was scheduled for request for rehearing:

35. The Claims Board originally heard the claim of Charles Locker on November 13, 1989, which claim was denied. Claimant has now petitioned the Board for reconsideration of his claim in the amount of \$11,243.75 for refund of sales taxes incorrectly paid to the state in 1983 and 1984. Claimant's accountant erroneously calculated 5% sales taxes on its wire-in floral sales from 1983 to 1988. On November 18, 1988, claimant filed

amended sales tax returns, requesting a refund of \$34,236.56. Claimant's refund requests for 1984 through 1988 were verified and allowed; however, liscal years 1983 and 1984 were closed to adjustment pursuant to the four-year statute of limitations under s. 77.59(4), Wis. Stats. The Board concludes that the petition for rehearing should be denied.
