Appendix to Senate Bill 515

Public Policy Involved

1989 Wis. Acts 31 and 117 caused about 320 county positions to be transferred to state employment-including 71 district attorneys who are elected officials. Of the 320 total, 85 are from Milwaukee and 235 from other counties. After the transfer and election rights, 286 of the total are under the WRS, and 34 have elected continued coverage under the Milwaukee County Plan. Of the 34, about one-half were not vested (10 years) as of January 1, 1990.

The previous Acts also allowed employees transferring from county to state employment to elect state fringe benefit programs or county fringe benefit programs, and to change a county election at a later date. However, state insurance programs such as ICI insurance and health insurance require participation under the WRS; and hence these state benefit programs are not available to employees electing continued coverage under the Milwaukee County Plan. Of the total 320 affected employees, approximately 166 currently have WRS and state fringe benefits, 120 have WRS and county fringe benefits, and 34 have Milwaukee Pension and county fringe benefits.

One purpose of this legislation is to allow transferring personnel who elected Milwaukee pension coverage to

elect coverage under the other state fringe benefit programs administered by the DETF. This is provided by amending the qualifying requirements under Ch. 40 for the state insurance programs, and by combining minimum service requirements to include service under the Milwaukee County Plan. It should be noted that this may or may not be an equitable solution if employers (Milwaukee County or the state) have chosen to give greater emphasis benefits and related costs. This new election process would allow personnel to 'chose the best of both worlds' in order to maximize the potential benefits and related employer costs.

Another purpose of this legislation is to address personnel from Milwaukee County who were not vested as of the transfer date of 1/1/90. If the non-vested participants elect coverage under the WRS, they would lose any rights to a county pension (including a separation benefit) because they were not vested, and they would have to serve five years as a state employee before they would be vested under the WRS. This bill allows for a transfer of service credit from the County Plan to the WRS, and a transfer of cerain assets to offset some of the newly accrued liabilities under the WRS. On the other hand, the transfer of service credits are from very different pension systems. The Milwaukee County Plan is non-contributory, while the state plan is contributory, although with permitted 'employer pickup' which may reflect reduced salary levels. Also, the County benefit plan for those hired after 1981 is less than the benefit structure under the WRS. It is not clear from this legislation whether the transfer of funds included amortization payments plus interest, and whether or not the transferring liabilities would be covered even if such payments were included.

There are two other possible solutions to a service credit transfer that might be considered. One process would clarify the amount of assets to be transferred (normal cost plus or minus amortization payments) and provide that the WRS actuary shall determine how much service credit under the WRS such asset transfer would buy. This procedure would cause no difference in benefit structures and employee contribution requirements of the two systems.

A second approach would be to credit the service under the WRS, and have the WRS actuary determine the actuarial liability involved in such credit. The full actuarial cost then could be charged against the Milwaukee County Plan. This approach would cause no additional unfunded liability under the WRS, but it could cause a funding loss under the County Plan. Of the two alternatives, perhaps the first alternative is the most equitable to all parties involved.

Recommendation

The Joint Survey Committee on Retirement Systems recommends the adoption of Senate Amendment 2. If the bill is so amended, the Committee finds that the

retirement provisions in this legislation reflects good public policy and recommends its passage.

As required by Article V, Section 6 of the Wisconsin Constitution, I am submitting the annual Executive Clemency Report to the Legislature, covering those clemency cases considered by the Pardon Advisory Board upon which final disposition was rendered during the calendar year 1989. Final decisions were made in sixty-five cases, with executive clemency granted in the following seven cases (all seven successful clemency applicants received full pardons):

James Thomas Aulozzi, convicted of burglary in Kenosha County on 9/11/67 and sentenced to three years probation, was granted a pardon on September 1, 1989 because of demonstrated need and the significant passage of time since the offense.

Roy B. Evans, convicted of theft in Milwaukee County on 10/22/84 and sentenced to three years

probation, was granted a pardon on September 1, 1989 because of his accomplishments since the conviction and the potential for his contributions to the community.

Terrence T. Fletcher, convicted in Racine County of forgery on 8/3/64 and sentenced to 3 years imprisonment, was granted a pardon on June 13, 1989 because of demonstrated need and the significant passage of time since the offense.

James Jennaro, convicted of soliciting a prostitute in Milwaukee County on 5/19/75 and sentenced to 2 years imprisonment in addition to a \$1,000 fine, was granted a pardon on July 5, 1989 because of his established need and an unblemished record since the conviction.

Raymond A. Peterson, convicted in Barron County of theft on 2/4/72 and sentenced to two years probation, was granted a pardon on August 24, 1989 because of demonstrated need and the significant passage of time since the offense.

Donald Pierce, convicted in Grant County of delivery of controlled substances on 2/26/82 and sentenced to two years probation, was granted a pardon on April 10, 1989 because he has no subsequent record of offenses and has made exceptional progress since his conviction.

Gene Zurbuchen, convicted on sexual intercourse with a child in Milwaukee County on 5/3/68 and sentenced to two years of imprisonment (stayed), probation, and thirty days in the county jail with Huber privileges, was granted a pardon on November 6, 1989 because of favorable circumstances since the offense and positive recommendations received from the prosecutor in the case and the applicant's employer.

I thank the members of the Pardon Advisory Board and my Legal Staff for their assistance in processing clemency cases and in the preparation of this report.
