The Department of Justice has completed its study of the crime victim and witness assistance program, as required under 1989 Wisconsin Act 31, sections 3034 (lg) and (lcm). On January 4, 1990, I submitted an interim report regarding cost control and program

restructuring issues, which Act 31 mandated be studied. Attached is the follow-up report referenced in that letter.

This report contains findings regarding cost control, as well as issues which the Legislature may wish to consider regarding the possible restructuring of the program. At this point it appears that a greater state role could help address issues of equity, service gaps and, to some extent, cost control. The Department intends to review alternatives in restructuring the victim/witness assistance program as it develops its 1991-93 biennial budget request.
