State of Wisconsin Legislative Audit Bureau

To the Honorable the Legislature:

We have completed an evaluation of the level and allocation of the Department of Natural Resources' administrative costs, as requested by the Joint Legislative Audit Committee. We also reviewed the causes and consequences of a projected deficit within the Conservation Fund, first reported in December, 1989.

There are indications that department administrative expenditures may be too high and could be reduced. There are also weaknesses in the way in which the Department allocates administrative expenditures among its programs. We have included recommendations to the Department to further review administrative costs for potential savings and to analyze methods to better allocate these.

Questions about the level and allocation of administrative costs are exacerbated by the deteriorating financial condition of the Conservation Fund. When measured by fund balances, each of the Fund's three major accounts in the worst fiscal condition in ten years. The Department and Legislature will need to address these funding problems. We list a number of options the Legislature could consider in deciding how to improve the financial condition of the Conservation Fund and to ensure its long-term solvency.

We appreciate the courtesy and cooperation extended to us by the Department of Natural Resources. The response from the Department is Appendix II.
