Should the hearing examiner determine that the motion of the other party in any chapter 227 contested case is frivolous, the examiner may award the state agency all reasonable costs in responding to the motion. To the Honorable the Legislature: We have completed an audit of the financial statements of the Patients Compensation Fund as required by s. 13.94, Wis. Stats. The audit covered the fiscal years ended June 30, 1989, and June 30, 1988.

Our report contains the financial statements and the related auditor's report for the fiscal year audited. Although we issue an unqualified auditor's report, we note that the Fund's reported losses are based on actuarial estimates, which will probably differ from the amounts ultimately paid.

In fiscal year 1988-89, there was a change in the past upward trend of the Fund's deficit balance; the deficit balance decreased \$14.4 million to \$108.3 million as of June 30, 1989. While legislative changes and other factors have contributed to some stabilization of the deficit, the deficit should continue to be monitored and evaluated bacause of its size and the unpredictability of the number and size of future claim awards.

Despite the Fund's somewhat improved financial position, further oversight and improvements are needed in the Fund's operations. Deficiencies in the Fund's claims operations resulted in several discrepancies in claims information, including information which is important for estimating ultimate losses and setting annual assessment fees. The Fund also lost \$142,000 in potential investment earnings on three checks which were never deposited. The Fund also needs to improve its enforcement of health care provider compliance to reduce the risk to nationts of uninsured health care providers.

We appreciate the courtesy and cooperation extended to us by the staff of the Office of the Commissioner of Insurance and the contractors who help administer the Patients Compensation Fund program. The response from the Commissioner of Insurance is the Appendix.
