To the Honorable the Legislature:

Pursuant to Wisconsin Statutes sections 73.03(29) and (30) the Department of Revenue is required to collect information from individual income tax filers concerning the school district in which they resided during the taxable year, and to notify the presiding officers of the houses of the legislature and the co-chairpersons of the Joint Committee on Finance of the results. Attached is a copy of the summary report covering tax year 1989.

Space was provided on all individual income tax returns for taxpayers to indicate the school district in which they resided by using a four-digit code. These codes conform with the codes used by the Department of Public Instruction. School district information was not requested on Homestead credit returns unless the taxpayer also filed an individual income tax return. Nonresident individuals who filed Wisconsin income tax returns were directed not to complete the school district space.
