Dear Mr. Melvin:

As required by 1989 Wisconsin Act 31, Section 3023 (24z), I am submitting the enclosed report. Act 31 directed the Department of Health and Social Services to:

"Study methods of expanding the use in rural areas nonphysician health care providers, including nurse practitioners, physician assistants, registered nurses and licensed practical nurses. By January 1, 1991, the department of health and social services shall submit a report on the study to the chief clerk of each house of the legislature in the manner provided in section 13.172(2) of the statutes."

The purpose of the study was to determine the following:

- The feasibility of establishing a specialized training program for nonphysician providers to perform colposcopic examinations and follow-up activities for treatment of cervical cancer;
- The need for expanded colposcopy services in rural areas; and
- The feasibility for the delivery of expanded colposcopy services by nonphysician providers in rural areas.

The study that is described in the enclosed report indicates the following:

- 1. The feasibility of establishing a specialized training program for nonphysician providers was successfully demonstrated. The training project under study demonstrated success in establishing an approved course curriculum, obtaining qualified faculty, and recruiting interested and qualified nonphysician candidates with the necessary organizational and physician support to practice within their community.
- 2. The need for expanded colposcopy services that are accessible and affordable in rural areas was identified.

3. The feasibility of delivering expanded colposcopy services in rural areas by nonphysician providers was demonstrated.

The Department of Health and Social Services will continue to provide support for the expansion of colposcopy services as required by statute. Several obstacles to the expansion of colposcopy services by nonphysician providers in rural areas have been mentioned in the report. The training project will continue to try to identify solutions to overcome these obstacles.

Representative Rosenzweig rose to recognize family and friends of U.S. Marine Scott A. Schroeder, the first Wisconsin casualty in Operation Desert Storm. She read the following memorial written by Stephen Hayes, a friend and former classmate of Scott A. Schroeder:

"Scottie, as most knew him, was liked by everyone who knew him. He was a good friend who always had a smile, a brother who was admired, and a son who had really grown up.

Scott, a 1989 graduate of Wauwatosa East High School, was a tremendous soccer player and was instrumental in back-to-back state tournament appearances by East.

Scott's greatest attribute was his positive attitude. Many people have a visual image of Scott with a big smile on his face. I am no exception. I played soccer with Scott for 10 years and was also in his Covenant class at church. Scott was seldom critical of others. He remained positive in times when it was very hard to look on the bright side. With all of the hate in the world today, Scott's bright smile was something that everyone could count on to remind us that there is still love; you just have to know where to find it. It is a shame that Scott, such a positive person, had to lose his life in the epitome of hatred; a war.

Scott's family issued the following statement: "Scott loved life and was proud to be a U.S. Marine ... Scott knew he was loved by his entire family and friends because he loved them first."

Scott supported President Bush in sending troops to the Middle East. Scott was a great representative of the U.S. and of Wisconsin.

Scottie was a great brother, son and friend. The pride that we can take in Scott helps us deal with our sorrow. His smile and cheer will be missed by all."
