GOVERNOR'S VETO MESSAGE

July 12, 1991

To the Honorable Members of the Assembly:

I am vetoing Assembly Bill 27 in its entirety. This bill would prohibit mining on state lands managed by the Department of Natural Resources, provide forfeitures for violations of the mining prohibition, and prohibit the Natural Resources Board from selling lands for the purpose of allowing mining on the lands.

I am vetoing the bill because it would completely ban mining on state lands managed by the DNR. Clearly, some DNR managed lands are inappropriate for mining. The land in which minerals are located may be so valuable to our environment that under no circumstances should these lands be altered. However, there is the potential that some DNR managed lands could be mined without injuring the environment or destroying the integrity of these lands. This bill would take away the opportunity for the DNR to consider such requests. In addition, the bill ignores society's need for certain types of minerals and the economic benefits that mining can produce.

Instead of an outright ban on mining DNR managed lands, I would consider legislation prohibiting mining only on unique lands managed by the DNR. As Wisconsin has the toughest mining laws in the country, I believe that other lands could be mined if deemed suitable by the DNR. This reasoned approach to mining on DNR managed lands will allow mining requests to be considered based on their individual merits and will continue to ensure that our state lands are protected.
