# **COMMUNICATIONS**

State of Wisconsin Legislative Audit Bureau Madison

November 27, 1991

To the Honorable, the Legislature:

We have completed financial audits of the State of Wisconsin Education Communications Board Television Network and Radio Network to meet our audit requirements under s.13.94, Wis. Stats., and as requested by the Educational Communications Board to fulfill the audit requirements of the Corporation for Public Broadcasting. Our audit reports contain the financial statements and the related independent auditor's report for the Television Network and related notes for the Radio Network for the period July 1, 1990, through June 30, 1991.

During the audited period, the Corporation for Public Broadcasting changed the accounting treatment for permanent property depreciation, and the Board was unable to make the accounting changes for fiscal year 1990-91. Because this accounting change had a significant effect on the Board's financial statements, we were not able to verify the account balances related to permanent property, accumulated depreciation, and depreciation expense as of June 30, 1991 and, therefore, presented a qualified opinion.

We will include management recommendations on improving permanent property records in a separate letter to be issued to the Board at a later date. We
