To the Honorable, the Assembly:

1989 Wisconsin Act 122 (s.146.183) provided funds to establish High Risk Pregnancy Projects. These Projects are responsible for identifying women who are at risk of a problem pregnancy due to alcohol and/or drug use, providing them with educational counseling regarding the risks of substance use during pregnancy, and referring them to substance abuse treatment as appropriate.

Act 122 also directed the Department of Health and Social Services to collect and analyze information about the High Risk Pregnancy Program and submit a report to the Governor and the Legislature by July 1, 1992. The attached report fulfills that directive.
