State of Wisconsin Legislative Audit Bureau Madison

To the Honorable the Legislature:

We have completed a review of staffing needs at the Centers for the Developmentally Disabled, requested as a result of a January 1992 emergency appropriations request to the Joint Finance Committee. At that time, the Department of Health and Social Services requested funding and authorization for 65 additional staff for Central Wisconsin Center, one of the State's three centers for the care and treatment of developmentally disabled residents.

Although the Department was aware during the preparation of its 1991-93 biennial budget request that staffing ratios at the centers might not be adequate to maintain federal approval for reimbursement under the Medical Assistance program, the Department delayed requesting any positions until its Bureau of Quality Compliance's independent review, conducted under the direction of the federal Health Care Financing Administration, confirmed the need for additional staff.

This review appeared inconsistent with earlier reviews and with findings at the other two centers in 1991, which

were approved although they had staffing ratios similar to that at Central. We found that the inconsistency with the previous annual reviews was a direct result of federal instructions implemented in 1991, which affected the conduct of the Bureau's reviews. The inconsistent results among the centers reflected the needs of Central Wisconsin Center's population, which is more physically disabled and has more serious medical problems than that of the other two centers. Although staff turnover rates and overtime usage have been higher at Central Wisconsin Center than at the other two centers, management actions at that center have reduced these problems.

The Department has proposed reducing the centers' population by approximately one-quarter in the 1993-95 biennium through increased community placements, which would allow the Department to increase staffing ratios. However, achievement of such an unprecedented number of community placements is uncertain, since it will depend upon counties' cooperation and successful implementation of new, untested departmental activities.

We appreciate the courtesy extended to us by the staff of the Department of Health and Social Services. A response from the Department is the appendix.
