To the Honorable, the Assembly:

Pursuant to 1991 Wisconsin Act 269, attached please find a report on the status of submerged cultural resources management activities by the State Historical Society of Wisconsin.

Since the formation of a small underwater archeology program in 1988, the SHSW has made significant advances in the identification, protection, and management of submerged cultural resources in state waters. Cornerstones of the program have been ongoing resource inventory work, pro-active public education and involvement, and efforts toward the designation of state bottomland preserves or marine sanctuaries in Wisconsin waters. Many of these accomplishments are due to joint projects with other agencies and grant assistance from outside sources. However, a more comprehensive program of state submerged cultural resources management, such as the creation of preserve areas, site management, and adequate law enforcement, will require a stronger state commitment, and commitment of funding, for the effective preservation and management of Wisconsin's maritime heritage.
