State of Wisconsin Legislative Audit Bureau Madison

To the Honorable the Assembly:

We have completed a financial and compliance audit of the State of Wisconsin as requested by state agencies to meet the audit requirements of the Single Audit Act of 1984 and provisions of the federal Office of Management and Budget Circular A-128. Our audit covers the period July 1, 1991 through June 30, 1992. In addition to satisfying audit requirements, the single audit assists us in meeting state audit requirements under section 13.94, Wis. Stats. Report 93-17 contains the auditor's reports on internal control structure and compliance; narratives for each agency which include our comments on internal control deficiencies, findings of noncompliance, and the results of our follow up to prior audit findings; agencies' responses to our recommendations and their plans for corrective action; and the Schedules of Federal Financial Assistance and accompanying notes. We have identified \$86,754 in questioned costs, plus an additional, undetermined amount of questioned costs.

Our audit opinion on the State's financial statements was included in the comprehensive annual financial report for the fiscal year ended June 30, 1992. This report was published by the Department of Administration in May 1993 and is available from the Bureau of Financial Operations in the Department of Administration. Our opinion was qualified because we were unable to determine the fair presentation of interfund transactions and other receivables and payables.

Our single audit report is lengthy and detailed. We are, therefore, limiting our initial distribution to those persons required by law to receive copies and to those who have an obvious and direct interest in our detailed findings. However, if you are interested in receiving a copy of the single audit report, please contact our office and request report number 93-17.

To the Honorable the Legislature:

I am writing to advise you of the status of a Commission report that is being prepared pursuant to 1991 Wisconsin Act 268, sec. 3. That law directed the Commission to prepare a study of how information generated in the course of a telecommunications transaction is used by the utility and third parties:

SECTION 3. Nonstatutory provisions; The public service telecommunications study. commission shall conduct a study to determine how telephone line identification numbers and other consumer information maintained by a telecommunications utility are used or may be used by that utility and how that customer information is accessed and used or may be accessed and used by other telecommunications utilities, by customers of the utility and by 3rd parties. The public service commission shall report its findings before July 1, 1993, to the chief clerk of each house of the legislature for distribution to the appropriate standing committees in the manner provided under section 13.172(3) of the statutes.

The Commission requests an extension of the deadline to file this report. The report addresses a subject matter, caller identification, that is presently under investigation at the Commission. At the time the legislation was enacted, we were of the belief that the Commission's investigation of caller identification would be completed by now. However, that investigation has been delayed to accommodate the schedules and funding requirements of the intervenor parties, and the technical hearings in this docket will be conducted during the week of August 9, 1993. Since the report will depend in part upon the factual matters that will be introduced at hearing and upon the order that the Commission will ultimately issue. it is important to protect against the appearance of prejudging this matter. Therefore, the Commission requests an extension by which to file this report until 30 days after the Commission issues its order in the matter of caller identification.
