the DNR was required to provide a copy of the economic impact study report to each of you. The City of Portage has hired a consulting firm, Economics Research Associates (ERA) to complete both studies (we contracted with the City of Portage to complete the economic impact study). My earlier letter indicated that ERA had missed several deadlines to complete the studies. I am writing now to update you on the status of the studies.

The Mayor of Portage appointed a steering committee to work with ERA, and a member of my staff (Doug Fendry) is an ex-officio member of the steering committee. ERA has provided the steering committee with draft reports, but the committee has found that the reports lack information necessary to complete the studies. The steering committee has met with a Vice President from ERA to outline what was needed to complete the studies, yet the studies still have not been completed to the steering committee's satisfaction. The City Attorney for Portage has contacted ERA to cancel the contract. ERA has responded by stating they feel they have met the requirements for the studies. Given the disagreement between the City and ERA, it will take several months to negotiate a settlement, and to complete the studies. I will keep you informed on the status of these negotiations.

I know the City of Portage is disappointed that ERA has not completed the studies, but I am confident that the City is doing everything in its power to resolve this problem.
