COMMUNICATIONS

State of Wisconsin Legislative Audit Bureau Madison

January 20, 1994

To the Honorable the Legislature:

We have completed an evaluation of the State's programs that regulate the transportation, storage and use of hazardous materials and respond to incidents involving their misuse, as requested by the Joint Legislative Audit Committee. We found seven agencies have significant responsibilities related to hazardous materials, including operating 47 programs and collecting \$75 million in fees charged for various activities.

In general, we found that the programs address known hazardous materials issues without substantial duplication of purpose or effort. Among regulatory programs, efforts to coordinate various inspection activities could be strengthened. In addition, providing a reasonable means for very small quantity generators to dispose of hazardous waste and regulating above-ground storage of noncombustible hazardous materials are issues that need to be addressed.

State efforts to assist local agencies in responding to hazardous materials accidents will be expanded if a sufficient number of advanced-skill response teams are trained and equipped. The Department of Natural Resources also needs to provide additional guidance and support to its wardens, who are the first to respond to accidents involving potential environmental damage.

If implementation of the newly enacted program for cleanup of sites where agrichemical spills threaten

groundwater and soil is coordinated with other environmental repair programs, the State will have addressed repair issues comprehensively.

Finally, while the number of fees collected for activities related to hazardous materials has grown rapidly in the past decade, there appears to be little duplication of purpose and some efforts have been made to reduce reporting burdens on those who must pay.

We appreciate the courtesy and cooperation extended to us by staff in all the agencies we reviewed.
