Pursuant to the requirements of section 153.35(1), Wis. Stats., I am pleased to submit to the Governor and the Legislature the fourth annual *Health Care Data Report*. This report was based on hospital inpatient discharge data reported to the Office of Health Care Information by all general medical-surgical and specialty hospitals operating in Wisconsin from January through December 1992. It also contains selected outpatient surgery utilization and charge data from general medical-surgical hospitals and freestanding ambulatory surgery centers in Wisconsin during the same period.

This report fulfills the statutory requirement to report "in a manner that permits comparisons among
